JUSTICE TO WOMEN IN WAR INDUSTRIES.

The Oregonian contains a statement that a conference has been held at the department of labor and Chief Deputy Gram announces . that "employment of women in hazardous occupations such as saw & and planing mills is not necessary at this time as thousands of men are still employed in clerical and other light positions." Hundreds 35 of women, many of them in comfortable "coveralls" are employed in saw and planing mills and box factories and getting two or three dollars a day for eight hours. They are rendering valuable and ; necessary service in such employment at Salem, Silverton and all over the state where there are any of these branches of the lumber & industry. If they like this kind of work and prefer it and aremaking good on the job what right has the state labor department to bar them from such employment, or try to force them to do elerical work for which many of them have not the necessary preparation? At Salem young women are working in the lumber industry who were stenographers and clerks for the simple reason that they | can make twice the wages as patriotic war industry workers that . they ever could get in the "light positions" referred to. As to such employment being hazardous, it is no more so for women than for men, and many a woman has had her fingers cut off or her hand mangled splitting wood or working a clothes wringer. Have we no longer a free country and is our boasted equal rights for women and . men a myth? It would seem so, if our labor officials have their way.

VERY PETTY POLITICS.

No man who has ever been considered big enough to even become a candidate for Governor of Oregon, much less to be thought of as possible of election, has stooped to such gutter-snipe methods . of campaigning as are resorted to by the present Democratic candidate, Walter Pierce.

One of his latest card devices seeks to arouse a most unworthy prejudice by innuendo against Governor Withycombe in the following preliminary statement:

"We need an American-born citizen for Governor at the head of our Commonwealth.'

This is a dirty and gratuitous insult to the thousands of naturalized citizens of Oregon who are doing their full duty in these trying times in every line of patriotic endeavor, and in this respect there could be no more active, earnest, enthusiastic supporter of our Government in its war aims, efforts and purposes than James Withycombe, whose inspiring words and actions as Governor since the beginning of hostilities have been a spur and an encouragement for every citizen to reach his full measure of national helpfulness.

To arouse racial animosity among loyal American citizens a this time is decidedly unwise, and this effort on the part of a candidate for Governor should be emphatically resented, not only by all naturalized citizens, but by those who desire to promote the unity of all classes in the genuine spirit of Americanism which is now devel-

oping with a greater strength than ever before. Wonder how ex-Governor West enjoys reading that card as he goes around the state advocating the election of a man who says that Oswald would not do for Governor bécause he was not American born ?-Statesman.


