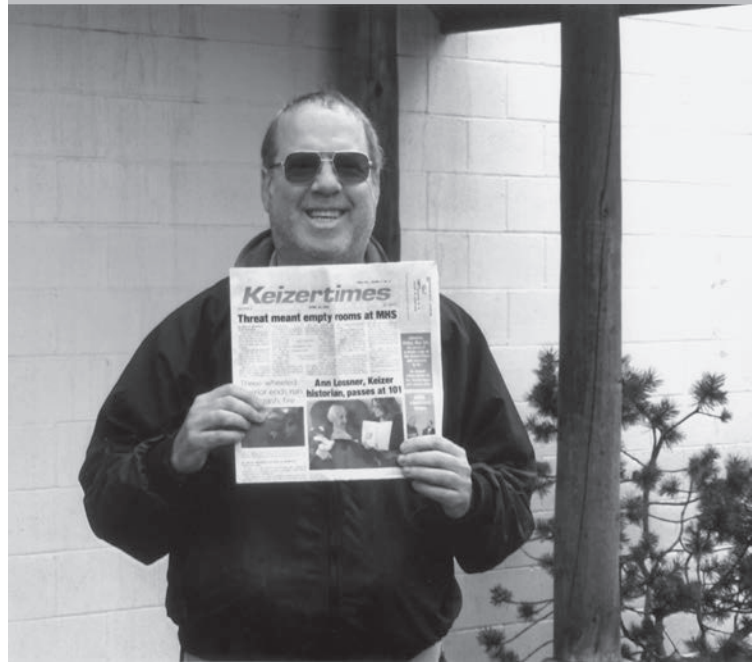


Passing the gavel
