Officer Babcock attempted to catch up to the stolen vehicle as it continued traveling westbound on Appleblossom Drive North, but it became apparent the driver was attempting to elude him.

Babcock saw the suspect vehicle turn right and travel through the Laurel Gate Apartments toward River Road North. He took a parallel path but the fleeing car never appeared. When he reached River Road and looked to the south for the suspect vehicle he saw it had crashed into another vehicle when the suspect pulled out of the Laurel Gate Apartments onto River Road.


Coffee with a Cop Aug. 8
