

Fire causes \$150K damage to Keizer home

The Keizer Fire District responded to the report of a house fire shortly before 6:30 p.m. Sunday, Sept 27.

The first unit arriving on scene reported heavy smoke and flames coming from the single family home on Spring Leaf Court North. One occupant had been asleep in the home at the time of the fire and had to escape past the fire in the living room. She was unable to escape out the window.

Salem Fire and Marion County Fire District both assisted with the fire.

No injuries were reported, but damage was estimated at \$150,000 for the structure and \$30,000 for the contents of the home. The cause of the fire remains under investigation. There was not a working smoke alarm in the home.
