

CCMS counselors to be honored in July

Claggett Creek Middle School will be honored for its counseling program July 11 in New Orleans.

The school will receive the Recognized ASCA Model Program (RAMP) designation at the annual conference of the American School Counselor Association. It is the first middle school in Oregon to receive the honor.

"It was one of those deals with a vigorous application process," Principal Rob Schoepfer noted. "It's a great honor for Claggett Creek, the school district and Keizer."

The RAMP designation recognizes schools that are

committed to what the association describes as "a comprehensive, data-driven school counseling program and an exemplary educational environment."

"This year's RAMP honorees have shown their commitment to students and the school counseling profession," said Jill Cook, ASCA assistant director and RAMP coordinator. "This designation distinguishes these schools and encourages school counselors nationwide to continue to strive for excellence."

RAMP applications are reviewed annually by a panel of school counseling professionals who assess counseling programs in 12 areas of program expertise, Cook said.
