Mayor Cathy Clark's first two-year term is expiring, as are the four-year terms of councilors Dennis Koho, Kim Freeman and Marlene Parsons.

Koho is resigning his seat on July 1 due to health considerations and an interim replacement will be appointed by the city council.

To run for the mayor or city council, candidates must be a qualified elector under the state constitution and a registered voter within city limits
