Car seat clinic Sept. 10

The Keizer Police Department will be hosting a free child safety seat clinic on Saturday, Sept. 10, between 8 a.m. and noon. The clinic will be held in the parking lot of Keizer City Hall, located at 930 Chemawa Road NE. Specially trained safety seat technicians will be on hand to inspect, educate and install safety seats and will have recall information available. It is recommended that children who use the safety seats be present at the clinic so proper fit can be established. Know your child's height and weight if attending with them is not possible. The clinic is designed to educate parents on the proper installation and use of safety seats. Sgt. Trevor Wenning said attendees should be prepared to learn, not just watch the technician install the car seat. Clinics are hosted on a first come, first serve basis and each check takes between 30 and 45 minutes - multiple seats require additional time. Bring car seat instructions and the vehicle owner's manual.




