

Salem man resists arrest after trespassing

A Salem man attempted to kick, punch and head butt Keizer police officers while being taken into custody for a trespassing offense Thursday, Oct. 27.

Officers responded to a complaint in the 700 block of Plymouth Drive Northeast about 5:45 p.m. The caller identified a man who was not supposed to be on the property.

After separating all of the parties, who were located inside an apartment at the address, the investigating officers learned the individual had harassed his mother prior to the officer's arrival.

The mother decided to pursue charges and a scuffle erupted as they tried to take the man into custody.

He was eventually placed in handcuffs and taken to the Marion County Correctional Facility.

Jonathan Daniel Morgan, 49, of Salem, was charged with harassment and resisting arrest.

KEIZER MAN ARRESTED FOR DOMESTIC MENACING

On Monday, Oct. 24, arrested a 54-year-old Keizer man who allegedly brandished a knife during a domestic dispute.

Police responded to a report of a man and woman roommates arguing in the 3800 block of Partridge Lane Northeast around 11 p.m.

Upon investigation, officers learned that the man had returned home from work and found the female and her 24-year old son had been smoking marijuana all day and she was stoned.

The woman reported the man had grabbed a knife during their dispute and threatened her with it.

George Diaz was arrested without incident and taken to the Marion County Correctional Facility where he was charged with domestic menacing.
