

# Carjacking suspect detained by samaritans

A man suspected of attempting to carjack a woman at a Keizer apartment complex was held down by witnesses until Keizer police could make an arrest.

About 2:45 a.m., Keizer officers were dispatched to 1607 Chelan Street N.E. after a breathless male caller could be heard yelling, "Help," over an open line.

Upon arrival, officers found a man being held down by a group of witnesses in front of the address. The man was later arrested and identified as Francisco Montalvo Jr.

The victim alleged Montalvo grabbed her hair from behind as she unlocked her 2012 Fiat and demanded that she hand over the keys. She slipped the keys into her pocket and began yelling. The struggle continued and she threw elbows until the

man let go of her.

Witnesses heard the commotion and chased after the suspect before catching up to him in front of the Chelan Street address where he had broken a porch post in the attempt to flee.

The victim said she recognized the suspect as a brother of a resident who lived nearby.

Montalvo was charged with third degree robbery (attempted carjacking), unlawful use of a motor vehicle, unlawful possession of burglar's tools and criminal mischief.

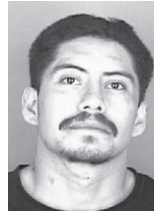
