

# Woman in domestic dispute attacks officers

A woman involved in a domestic dispute with her boyfriend turned her attacks toward officers trying to de-escalate the situation Friday, Feb. 3.

Officer Eric Jefferson was summoned to an apartment in the 5300 block of River Road North about 9:30 p.m., on a report of a woman hitting a vehicle and screaming loudly.

The woman continued to act out as the officer investigated the situation and found that her boyfriend had locked himself in the vehicle. She was placed in handcuffs and released when there was no evidence of domestic assault found.

As arrangements were being made for another relative to come and assist, Jefferson wrote the woman "went into a rage again" in a probable cause statement.

After being warned about disorderly conduct, the woman attempted to run inside her

apartment and was pursued by officers. When she tried to slam the door on an officer, she was told she was being placed under arrest. Jefferson wrote

the woman attempted to hit and kick officers, and kneed one of them in the groin after being placed in handcuffs.

She was taken to the ground and began spitting at the officers. After being placed in a spit hood and hobbling restraints, she was transported to the Marion County Correctional Facility.

Emily Pantalone, 26, was charged with disorderly conduct, assaulting a police officer, resisting arrest and two counts of harassment. Bail was listed at \$22,500.
