

Turner man arrested for giving teens weed, alcohol

A 22-year-old Turner man was arrested shortly after midnight on Friday, April 21. He allegedly supplied two Salem teens with marijuana and alcohol while in Keizer.

A suspicious vehicle was reported in the area of Tepper Lane Northeast and Jaymar Drive Northeast about 12:21 a.m. A 9-1-1 caller reported seeing one of the occupants exit the vehicle and jump a fence into a neighbor's yard.

Officers arrived and found the 22-year-old along with two passengers ages 16 and 17. Further investigation revealed all three had consumed alcohol and marijuana after parking at the location. The person who exited the car had relieved themselves on the fence, not jumped over it.

Guadalupe Cruz-Hernandez admitted to officers he had supplied the alcohol and marijuana. He was arrested and charged with two counts of providing liquor to a person under 21 and two counts of delivery of marijuana. He also

had an outstanding warrant issued by Mill City Municipal Court.

The teens were released to relatives at the scene.

MAN ARRESTED AFTER SUSPICIOUS ACTIVITY REPORT

About 9 a.m. on Saturday, April 22, Keizer police officers responded to a report of suspicious activity in the area of Shady Lane Northeast and Brooks Avenue Northeast.

A 9-1-1 caller reported there was a male subject who was walking around the intersection yelling, waving his arms and looking into parked vehicles. The suspect was described as a male in his 30s, carrying a green University of Oregon backpack and wearing a grey hoodie, grey sweats, a camouflage baseball hat and not wearing shoes.

The subject was contacted moments later by the responding officer and he was identified as 42-year old Joshua Can Duncan, a transient with no permanent address.

Further investigation re-

vealed Duncan's presence in the neighborhood violated a restraining order and he was taken into custody. While searching the suspect, the responding officer found methamphetamine.

Duncan was taken to Marion County Correctional Facility and he is charged with violation of a restraining order and possession of methamphetamine.
