

# 59-year-old arrested for meth delivery

A man suspected of driving while revoked locked himself inside his car and refused to engage with Keizer police officers during a traffic stop.

Officers eventually shattered one of the car windows to place the man under arrest.

The incident began about 2:30 a.m. June 21 when Officer Esteban Perez observed a 2000 Chevrolet Malibu allegedly driven by Brian Richard Beesley, 59, on River Road North. Beesley's license had been revoked after repeated DUIs and felony convictions on drug-related charges.

Perez initiated a traffic stop and waited for additional officers to arrive on the scene. The suspect refused to leave his vehicle and locked himself inside before officers approached.

After the driver's side window was broken, the door was opened and the suspect was pulled to the ground where he continued to resist arrest. Once he was cuffed, investi-

gating officers found the suspect in possession of methamphetamine packaged for delivery.

Beesley is charged with driving while suspended (felony revoked), resisting arrest, unlawful possession of methamphetamine and unlawful delivery of methamphetamine.
