

Man sics dogs on paramedics

Keizer Fire District responded to a skateboarding injury that ended with the patient siccing his dogs on the first responders.

On Sunday, July 31, medics responded to 2036 Kennedy Circle N.E. to assist a 19-year-old man with a skateboarding injury. The man was allegedly unhappy with the treatment of a minor knee injury during the

response and, as medics prepared to leave, let his dog out of the house and told it to go after the medics. Two of the medics were bitten.

After police were summoned to the scene, Lizandro Garcia-Guzman was arrested and charged with harassment, interfering with a firefighter and reckless endangering. Bail was set at \$12,500.
