

Head-on collision sends 4 to hospital

A head-on collision, allegedly due to driving under the influence, sent both drivers and two passengers to the hospital with injuries Saturday, Oct. 28.

Keizer police officer responded to a report of a crash on River Road north near Fir Cone Drive Northeast about 7:40 p.m. The roadway was blocked by the two vehicles involved in the crash, a 1992 Volkswagon Cabriolet and a 2015 Dodge minivan.

The preliminary investigation led investigators to believe the Volkswagen was only occupied by one individual, the driver who was identified as 28-year old Uriah Jonathan Gibson of Keizer. The Dodge minivan was occupied by its driver, 35-year old Natalia Marie Child of Salem, her 14-year old son, and 70-year-old Shirley Jane Roberts of Keizer.

Witnesses said the Volkswagen was traveling south on River Road and the minivan was traveling north when the collision occurred. All of the

individuals who were involved in the traffic crash were transported to Salem Health for evaluation and treatment of their injuries.

The traffic crash is still being investigated by the Keizer Police Department and members of the Marion County CRASH Team. Anyone having witnessed the incident is asked to contact Officer Martin Powell at 503-390-3713, ext. 3502.

Gibson was cited for driving while suspended (misdemeanor), criminal mischief in the first degree for striking a light pole, driving under the influence of intoxicants, reckless driving, and three counts each of reckless endangering and assault for the injuries caused to the driver and occupants of the minivan.

River Road North was closed between Fir Cone Drive Northeast and Nottingham Drive Northeast for more than three hours while police investigated the incident.
