Rangers, hosts, and volunteers are transforming the Silver Falls State Park's Historic District into a Christmas wonderland for the 40th annual Christmas Festival. The event will be on Saturday, Dec. 9, from 11 a.m. to 4 p.m. in the South Falls Historic District.

Musicians and choral groups provide the sounds of the holidays. Visitors can enjoy cookies and cocoa as they gather in the South Falls Lodge area to hear seasonal stories and music in the afternoon. Or they can get in the spirit by creating make-and-take projects such as holiday cards, gingerbread houses, festive ornaments, wreaths, nature crafts, and more. There will be guided hikes to enjoy the park in its winter splendor. The Salem Audubon Society is supplying parts, tools, and expertise for bird nest boxes. There is a \$5 materials fee for



the bird nest boxes. All other crafts and activities at the festival are free.

The Silver Falls Lodge and Conference Center will be offering roasted chestnuts, popcorn, coffee and cocoa, as well as holiday craft stations and carnival-style games with prizes. There will be snowflake flurries each hour. A small selection of lunch items will be available for purchase in the hall. A shuttle bus will run continuously between the conference center and the South Falls Day Use area.
