Child, 7, has run-in with car near school

A child crossing outside of a crosswalk was struck by a slow-moving vehicle on Clear Lake Road N., near Forest Ridge Elementary School.

About 3:40 p.m., Keizer Police Department received a report of a vehicle vs. pedestrian collision in north Keizer.

A 7-year-old student had attempted to cross Clear Lake Road heading north when she was struck by a vehicle moving through a congested area. The child fell to the ground and received a bloody, possibly broken, nose.

"This was a slow-speed, low-impact crash with no damage to the involved vehicle. The driver of the vehicle remained on scene, assisted with first-aid until medics arrived, and fully cooperated with the investigation," said Sgt. Jeff Goodman of KPD.

The primary cause of the crash was the pedestrian not using a crosswalk. There is a crosswalk located at the intersection of Clear Lake Road

and Wheatland Road a short distance from where the child attempted to cross the street.

School officials sent out an auto-dialer call alerting parents of the incident and offered counseling to students who requested it.
