me,” Namburi said. “I still work decently hard and it's not just that certain things come easy to me and I don't put in any effort. I've always been good at test taking in school.”

“At Sonshine, they were very careful making sure I wasn't pushing myself too hard,” Namburi said.

“They were willing to work with me. They were flexible, especially since it was very soon after my surgery. My entire time there they were really nice about taking care of me basically like I was their own son and when I made the transition to Blanchet from Sonshine, I think Blanchet just picked that up because it's such a small school, it is like a family atmosphere, both of them, and they understand where I have my limitations and they've

been willing to work with them.”

Namburi is inspired by his older brother Aneesh, a senior at Blanchet.

Basketball, golf, DECA, Science Olympiad, whatever Aneesh does, Nikhil follows.

“Aneesh is my best friend in the entire world. Nikhil said. “He literally wakes me up every single morning. He makes me breakfast because I am not a morning person at all. I think a lot of his success, he's always been a very hard working individual and seeing that it became easier for me to understand what it take to be successful because he's done a great job of it.”
