## Titans win big on the road

West Salem (2-1) overcame a slow start to defeat Grant 40-22 Friday, Sept. 14 on the road.

The Titans relied on their run game to stretch their lead from 19-14 at halftime.

Quarterback Simon Thompson rushed for 117 yards and a touchdown. Thompson also passed for 215 yards, two touchdowns and two interceptions.

Jordan Whitaker finished with 20 carries for 87 yards and two touchdowns.

Tight end Micah Pugh caught two passes for 95 yards and a touchdown. Jamal McMurrin also caught a touchdown pass. Anthony Gould finished with four receptions for 75 yards.
