PURPOSE OF HEARING: The City Council will hold a public hearing to consider proposed revisions to the Keizer Development Code to amend Section 2.403 (Shared Housing Facilities) to modify standards for Accessory Dwelling Units governing parking and owner occupancy requirements, in order to be consistent with state law.
