**Marion County Fire District #1**

Marion County Fire District #1 provides emergency services to residents in 80 square miles of the county which includes homes, agricultural land and businesses. Those 80 square miles are home to more than 50,000 people including 1,000 homes in north Keizer.

The fire district currently employs 52 full-time personnel, three part-time personnel and 60 volunteer firefighters. One fire truck, one water tender and a medic unit along with five firefighters/EMTs are housed at the District's Clear Lake Station on Wheatland Road. The district has eight stations throughout their service area.

Fire Chief Kyle McMann has been with the agency since 2001. Chief McMann and senior personnel ensure that Marion County Fire District #1 fulfills its mission of making a positive difference in the community. That is accomplished by providing an effective emergency response and taking appropriate actions in all emergency situations. The District saw a 5.6 percent increase in emergency calls in 2019, including overlapping calls 55 percent of the time.

Marion County Fire District #1 passed its annual independent audit, which included financial statements and cash funds. Mike Welter, president of the district's board of directors said, "It's important for our community to know that we are good stewards of their tax dollars."

The fire district is involved in the community with an annual food and toy drive each holiday season, open houses and their annual pancake breakfast at the Brooks station every March.
