the police," Farrand wrote. After the man made shooting gestures with his fingers near Farrand's face and refused to move along, Farrand called 9-1-1 to report the matter. The man then turned and ran south along River Road North.

After taking a report, Keizer Police Department officers located the individual walking along Cherry Avenue Northeast.

"The individual is a local transient and we have had multiple encounters with him. He likes to yell at anybody who happens to be in the area," said Lt. Andrew Copeland of the Keizer Police Department.

Copeland said responding officers watched the man from a distance and he appeared to have calmed himself down. Police are not aware of anyone the man has physically assaulted.


