In-district student transfer applications open Nov 1-30

Students who want to attend a school other than their assigned school may apply for an in-district transfer (IDT) between November 1-30. This includes elementary, middle, high school and students who would like to transfer to the EDGE online program.

If your student already has an approved IDT, you do not need to fill out the application.

There is no guarantee a transfer request will be approved. Students

attending school on an IDT are not eligible for bus transportation. IDT applications received after November 30, will not be considered.

In-district transfer request forms can be picked up at your student's assigned school. They will also be posted on the Student Transfers page on November 1. The webpage will also include instructions on how to turn in the forms via email or snail mail.

It is preferred that families fill out

the forms and drop them off at their assigned schools.
