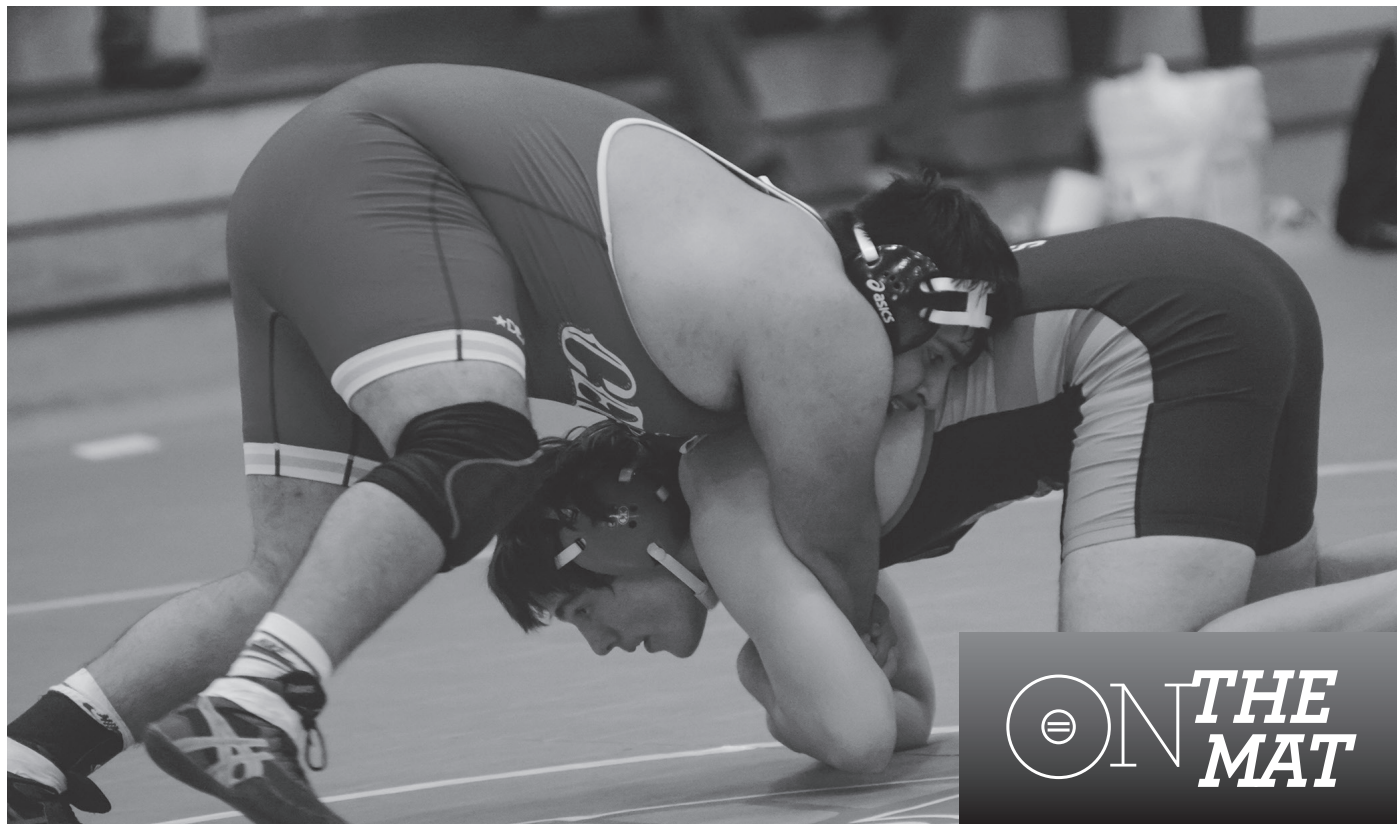


# Cruz-Lopez places first at Joe Stewart Invite
