## D. C. Housing **Built For Negroes**

More than 19,300 accommodations for Negro war workers are included in the war housing program for the Washington, D. C. metropolitan area, John B. Blandford, Jr., Administrator of the National Housing Agency, announced this week.

These new accommodations will be in addition to the 2,024 family units and 1,376 dormitory accommodations that had been completed for Negro war workers by July 31, Mr. Blandford said. At the same time, work is now being pushed on the installation of 400 mobile houses and 350 dormitory accommodations, while 107 demountable houses are being finished for oc cupancy after movement from Suitland, Md.

The new 10,326 accommodations will include 5,425 units provided by private financing, and 4,901 units provided by public financing. > Because of limited wartime supplies of critical materials, this housing was designed to meet only the needs of incoming war workers and those workers evicted from their homes through no fault of their own. The figures include only housing built under wartime priority control.

The war housing program for the area includes 51,201 family dwellings of which 34,293 are being privately financed. Over 30,000 additional units were constructed by private builders, without priority assistance, during the earlier period of the defense effort.

Public financed construction includes 16,908 family quarters, 11,-176 accommodations for single workers in dormitories or residence halls, and 64 trailers that are used as stop-gap shelter. In addition 107 trailers and 400 mobile units have recently been added to the stopgap program.

Mr. Rainey, prominent in Boston legal circles, resigned last Friday as attorney for the Office of Price Administration in the New England area.

He presented his resignation, he said, because "I could not remain silent during this campaign while laboring under the responsibility to protest against a most subtle and vicious plan to perpetuate in America a second-class citizenship for by people."

Mr. Rainey was formerly Assistant Corporation Counsel for Boston and has served as special attorney for Massachusetts in the Department of Jutice. He headed the Colored Division of the Democratic National Committee in the last four presidential campaigns.

Accepting Mr. Rainey's support of Governors Dewey and Bricker, Herbert Brownell, Jr., Republican and added:

"His voluntary action in declaring support of the Republican ticket is further evidence of the growing conviction among Negroes that in the Republican party lies their hope for advancement and preservation of the Negro's constitutional rights."

## **Overcharges Bring Injunction Suit**

Jim Lee, proprietor of the China brought by the district OPA en-Court of Multnomah County, asking for an injunction barring the restaurant operator from charging more than ceiling prices permitted by OPA regulations, Cecelia P. Gallagher, OPA enforcement attorney announced today.

"This is the beginning of an intensive drive during which the base period filings of every Portland restaurant will be checked," Miss Gallagher declared.

The investigation, made under the direction of Charles Kaufman, OPA compliance chief, disclosed that prices on over a hundred items served by the China Clipper had been raised not once, but several times, resulting in overcharges to the public exceeding \$7,000.

Restaurant prices were frozen during the period April 4-10, 1943, Kaufman explained. Several menus brought to light by OPA investigators revealed that Lee had at different times changed and altered his menus and listed the same food and drink items at higher prices.

Lee is sole owner of the China Clipper restaurant which purportedly does business close to \$100,-000 a year. He admitted to investigators that he had raised his prices above those permitted by regulations. On subsequent check of his restaurant, he was found still to be selling at excess prices, Kaufman said.
