An Outrage.

The recent action of Commissioner Richards in withdrawing a vast amount of land from entry under any of the government land laws in Crook, Klamath and Lake counties is an outrage of the worst kind.

The editor of the Review is a strong believer in reserves, but this latest withdrawal is carrying the thing too far.

The land that is worth anything at all has been taken up and that which is left is absolutely worthless, so to say that it is for the saving of the timber, is but a mere pretense of the most flimsy character.

It was never intended when the law establishing reserves was passed that any man, be he high or low, great or small, assume to himself the power and arrogance of Commissioner Richards has, and withdraw indiscriminately, land like he has in this last withdrawal, when there is no foundation or base for such withdrawal, and which does work and will continue to work irreparable injury to all and not a penny's benefit to any one.

As there is now, probably 75 per cent of Klamath, Lake and Crook counties in reserves, we would advise Commissioner Richards in his superior and infallible wisdom to act once more and place the other 25 per cent left in a reserve, and in the same order say, you worthless vagabonds who inhabit this accursed territory that my ban has fallen on deserves no recognition whatever, and you are just a degree below the Indians who are allotted reservations.

Before leaving The Dalles for Salem to confer with the Portage Railroad Board, A. B. Hammond, engineer in charge of the line being run for the Portage Road, gave out the following interview:

"I have moved my party of surveyors from Sauter's Cannery to Gellie to complete the survey for the Portage Road in that vicinity. At present the survey of the new road passes over the O. R. & N. right of way at four different points.

"As soon as I know exactly what will be needed, which will be within the next few days, the state will commence condemnation suits against the railroad. The O. R. & N. is trying to run a bluff on the state, but I think we will soon call it when it comes to trial in Wasco county. If they should appeal to the Supreme Court to cause a delay I think the state will be able to have it advanced on the docket, causing little delay to the work.

"From all appearances at present I will succeed in building this road within the appropriation, regardless of the action of the O. R. & N. Co. in attempting to throw obstacles in the way of the work.

"It is generally remarked here that the different stand the president of the O. R. & N. has taken on different occasions. The State of Oregon asks for permission to use part of the road's right of way, because it is unable to build its road in the Columbia River at these different places. Mr. Mahler replies this is a very valuable piece of ground and cannot be parted with at any price. In the past when the company has changed its track or obtained valuable property it has set up in Wasco county that this land was entirely worthless and without any value to the owner or the buyer, giving the owner almost nothing for the land. The company will, no doubt, very soon have to explain to the people of Oregon where this vast difference in price comes in."—Portland Journal.
