MORE RELICS.

Recently Added to the Oregon Historical Society.

George H. Himes, secretary of the Oregon Historical Society, who has just returned from a trip throughout the state in the interests of the society, kindly furnishes the following:

The rooms of the Oregon Historical Society are becoming a center of much interest, and many people are being attracted thither by the display of relics of the early days in Oregon. Most of these were brought across the plains and serve today as object lessons, or blazes along the trail of progress. Among recent accessions mention may be made of the following:

"The commission of Joseph Lane, the first Territorial Governor of Oregon, dated December 20, 1848. The document bears the signature of James K. Polk, President of the United States, and James Buchanan, Secretary of state.

"Payroll of Captain Edward Swain's company of riflemen, discharged at Wicasset, Me., September 25, 1814.

"A gambling device, turned by Horatio Cooke, father of James and Vincent Cooke of this city, in Chicago in 1841, and brought to Oregon in 1853. The device is a marvelous piece of exceedingly fine workmanship, which Mr. Cooke retained during his lifetime because the gambler who gave the order refused to pay for the work on delivery.

"A ticket of admiration to the impeachment trial of Andrew Johnson at Washington on April 13 1868.

"Program of Portland Academy and Female Seminary, April 11 1860.

"Account book of Rev. David Leslie, 1837 to 1846."—Portland Journal.

Williamson For Congress.

"Newt" Williamson, as he is called at home in Eastern Oregon, is purely a man of the people. His residence is at Prineville, and he has for a number of years been engaged in the sheep business and in stockraising. To see him in his home town or on his ranch one would never take the new congressional nominee for a political aspirant. In town he mingles with the "boys", being often seen with groups of them on the street corners, and is the most common looking one of them all in dress. He generally wears a pair of overalls and a broad-rimmed hat of the sombrero pattern, and has a natural kind word for every one he meets. He is not of the stripe who go in this attire for effect, but it is natural. Mr. Williamson has spent his life that way, and he thinks nothing of meeting prominent men who visit Prineville in his overalls. On his ranch it is the same way. He can lasso a broncho or shear or butcher a sheep as quick as any employe on his ranch, and he is not backward in taking hold when it comes to manual labor of any kind. Still, when one looks into the eyes of J. N. Williamson and sees the spark of intellect there, together with a classic, clean-shaven face and a voice naturally eloquent and pleasing, he sees in the man more than a politician. He is an American statesman.—Astorian.
