The Review in a recent issue says that the record of J. J. Smub as county clerk is above reproach, and denies the accusation that one of his mistakes cost the county \$600. We do not wish to unjustly criticise Mr. Smith, or be understood as saying anything against him personally, when we say that we do not believe his record is above reproach. What we mean by this is his official record in the county clerk's office and not his personal record. We are willing to admit that Mr. Smith is a man of good intentions, yet his fitness for the county clerk's office must be measured not alone by his good intentions, but by his clerical accuracy and business ability as well. Several grave errors have been charged against him during his incombency of the county clerk's office, among which is the \$600 mistake referred to by the Review. This is the most important one that has so far come to the surface and the most farreaching in its consequences, and is the blunder made in making up the record in the Casey road matter, upon which the decision of the circuit court turned, and which resulted in the defeat of the county in the suit against W. T. Casey, in volving an expense to the taxper volving an expense to the taxper ers of several hundred dollar. This was clearly the mistake of the county clerk, though the Review may endeavor to shoulder the blame on some one else. But the fact remains that a mistake was made in the records, and this mistake was in the form and completeness of the order for the view of the road, as well as in the final order declaring the road a public highway. The Review may say that the judge's docket in this case was followed literally, and that it was not the fault of the county clerk because the orders were not in proper form. But this in no wise excuses the county clerk, for the judge's docket in the county court as well as the circuit court is merely a memorandum of business transacted, while the journal, as written up by the clerk, should be full and complete, showing the jurisdiction of the court in all orders made by the court.
