Discovery of the Smallpox Germ.

The announcement that Professor William T. Councilman, of the Harvard Medical school, has discovered the specific germ of smallpox will be received with much gratification by bacteriologists.

From a practical standpoint of disease prevention, however, it will doubtless prove of no special value, as vaccination covers every necessity in that direction.

While, scientifically speaking, the isolation of the germ may prove in a more logical way than was before possible the real value of vaccination, it can hardly be expected to do more than possibly modify present methods of inoculation by guaranteeing in an absolute way perfectly pure virus under all circumstances.

It is well known that pure virus can never produce anything but its own kind and that all variations from the rule are due to accidental contamination of the inoculation wound.

It may not be improbable, arguing from analogy, that the new discovery will open up a way for such a cure of the disease as is paralleled by the use of anti-toxins for diphtheria.

The fact also that the organism is a protozoa opens up a wide field of research for a similar causative element in the various eruptive diseases, and possibly even in cancer.
