## Remarkable Growth at Lamonta.

A trip through the Lamonta district shows astonishing development and progress there during the past twelve months. New homes are springing up on every hand, sage brush is being replaced with stubble fields and large tracts that have in years past been thought to be worthless have proven to be some of the best agricultural lands in Crook county. No irrigation is necessary in this section and an abundance of good well water is available at a depth from 20 to 40 feet. A new townsite has been laid off and many lots have already been sold. J. C. Rush has a large general merchandise store here and is postmaster. He is doing a thriving business and is proprietor of the townsite and is altogether the "leading citizen." Last September M. T. Cowan and his son-in-law F. H. Mingers came to Lamonta from Chisago county Minnesota and bought town property. Mr. Cowan built a good hotel building and feed barn and immediately entered upon a successful business. Mr. Mingers erected a substantial blacksmithshop and went to work at his trade. Last November their families joined them. Mr. Rush has also completed a neat business building which will soon be opened up as a first-class drug store. One-half mile from the post office and store is the public school building where the rising generation receives instruction and where religious services are held most every Sunday. During the year the Grizzly Lake Sawmill Company erected a mill five miles east on the slope of Grizzly mountain and are supplying the neighborhood with first-class lumber at reasonable prices. Lamonta is located in the center of a fertile agricultural district and in reasonable course of development cannot fail to be a good sized town. The survey of the Oregon Eastern line runs through the townsite, thence ten miles south east to the crossing of Crooked river near Forest. It is a slightly community and with the advent of the iron horse Lamonta will quadruple her productions to swell the business of the railroads and add prosperity and luster to Central Oregon.

## Fine Ranch from Road Company.

Montgomery Brothers recently purchased a section of wagon road land adjoining the farm of their father, J. M. Montgomery, on Crooked river six miles below Prineville at the reported figure \$8 per acre. The lines run on to the rim rock in some places but the buyers have secured a large acreage of the finest land in the valley, and now have a crew of Indians engaged in clearing it of sage brush ready for the plow. Nor is this the only tract of the river bottom land so long unused for agriculture that is being cleaned up ready for cultivation. All along the road between Prineville and Forest land holders are doing a great deal of clearing work so that indications are most favorable for an enormous increase in the tillable area of Crook county lands for next years cropping.

## Railroads After Ties.

Additional evidence along the line of railroad activity in this portion of the state is shown in the recent inquiries being made by the purchasing agent of the Southern Pacific relative to the manufacture and delivery of pine ties.

A short time ago The Journal made mention of the fact that the Great Southern was negotiating with the U. S. Cowles Sawmill for the purchase of railroad ties, and since that time the Southern Pa-

cific has asked another mill company in western Crook county to submit bids for the manufacture and delivery of ties at Forest, Redmond and Bend. The latter request came from the San Francisco offices of the Southern Pacific, and shows plainly that the surveys now being made by that company from the north are not idle work. It is not known at this time whether Mr. Cowles has made any definite contract for the manufacture of ties for the Great Southern.
