The college grounds, consisting of 250 acres, are located within the western limits of the city. The campus proper, covering about forty acres, is heautifully decorated with magnificent specimen trees, flower beds and groups of shrubbery. Broad drives and walks traverse the grounds in every direction and add to the attractiveness of the place.

In place of the single brick building which housed the college in 1885 and which now serves as the administration building there are twenty structures, many of which eclipse in every way the original college home. On each side of it is a beautiful-gray stone building, one of which is now called the chemistry building and the other mechanical hall. The next row






