Drastic Changes in Amended Treaties Make Resubmission Necessary.

Washington -Stripped of the clause which, it was contended, would invade the constitutional treaty-making power of the senate, and with many other limitations added, the general arbitration treaties between the United States and England and France, were ratified by the senate by a vote of 76 to 3.

Virtually the treaties are "up in the ir." and in their modified form they must be referred to England and France.

The amendment provided that the treaties do not authorize the submission "to arbitration of any question that affects the admission of aliens into the Untied States, or the territorial integrity of the several states or of the United States, or concerning the question of the alleged indebtedness or monoyed obligation of any state of the United States, or any question which depends upon or involves the Monroe Doctrine, or other purely governmental policy."

Bar Liquor From "Dry" State.

R begins to look as if this congress is going to pass a law which will make it impossible for liquor to be shipped into states which have prohibition laws.

The fact that congress is likely to pass a measure which will restrict the shipment of liquor into prohibition states shows that the anti-liquor interests are gaining, but more than that is the almost sure indication that lisquor selling in Washington will be greatly restricted by legislation which is to be passed this session.

Sulzer Bill Omits Boxed Apples.

Washington .- The house committee, after hearing arguments on the Sulzer ap box bill, will abandon the original measure and report a substitute which undertakes merely to regulate the size of apple barrels and fix stand ards for apples packed in barrels. This is in conformity with an agreement reached between western grow ers and eastern commission men.

The bill that will be reported does not in any way apply to western apples packed in boxes. There is one clause of the bill, however, which later on may be extended to western apples. This clause imposes a fine of \$1 for each package of apples misbranded and provides for confiscation of each barrel that is short.

Canal Bill Fixes Maximum Charge.

The blil for the government of the Panama canal zone and the operation of the canal was agreed to by the house committee on interstate commerce. It would give to the president authority to fix tolls within certain limitations, a maximum of \$1.25 a ton being prescribed, with a minimum not below an amount sufficient to maintain and operate the canal. No preference would be given to American ahips.

Ships owned or controlled by rallroads and operated with intent to restrain trade, or ships engaged in any agreement or "ship ring" or combine. under the terms of the bill, would be prohibited from passing through the canal.

TAFT SCORES POLICY

Assails New Doctrines as Beginnings and Manifestation of a Despotism.

Chicago .- In an address before the Swedish-American Republican league of Illinois, Mr. Taft assailed the new doctrines advanced by Theodore Roosevelt as "the beginnings and man ifestations of a despotism."

"Such a government," said President Taft in discussing the recall of judicial decisions as advocated by Colonel Roosevelt in his Columbus speech, "would lack uniformity of law which is essential to justice, and would produce that confusion and those exceptions in the application of law which are the beginnings and manifestations of a despotism."



CAPTAIN AMUNDSEN REACHES SOUTH POLE

London .- Scientific men here, after reading Captain Roald Amundsen's committeemen. graphic account of his discovery, is generally acknowledged as the conquerer of the pole.

The real dash was started October 20, 1911, but four men accompanying the explorer. They took four sledges and 52 dogs, with food supplies for four months. Snow pillars six feet high were made to guide them on the return journey. The eighty-fifth parallel was reached November 17. Ceremony at Pekin is Noteworthy, But Legations Are Not Represented.

Pekin .-- Yuan Shi Kai was formally maugurated provisional president of the Republic of China in the presence of a great gathering of delegates, provincial envoys, military and naval officers and other prominent personages in the new foreign office. Many forsigners attended the ceremony, but the legations were not represented. Yuan Shi Kal, who was in military uniform, read a declaration promising

faithfully to develop the republic, observe the constitutional laws and retire when the national assembly appointed a permanent president.

Most of those attending were attired either in uniforms or European dress. The only touch of Orientalism was the presentation of the scarfs to Yuan by two yellow-robed llamas.

The ministers and military commanders at Pekin and Tien-tain continue to take precautions against eventualities. It is not considered. likely that the disorders in these cities will become anti-foreign. The misalonaries, who know the people better than anyone else, say there is no rea son for alarm. Diplomats and milltary officers, however, argue that the recent outbreak came without a moment's notice and believe that possibly the Chinese artillery may be turned upon the foreign concessions without warning.

Presidental Primaries in Michigan. Lansing, Mich .-- The house of representatives passed a presidential primary bill to take effect immediately. The bill provides for a primary on the first Monday in April, binding the national convention delegates to support the presidental nominees securing the majority at the primary.

Washington State Convention To Be

Held in Walla Walla on May 6. Seattle .- Walla Walla as the place and May 6 as the date, were chosen for the Democratic state convention by the Democratic state central committee. There was bitter opposition to the calling of the convention for May 6, the Harmon and Clark leaders endeavoring to have it called for a later date.

The committee decided that in counties of 5000 population or over, regular county conventions be held with delegates chosen at precinct caucuses. In the more sparsely settled counties, the method of holding county conventions is left to the county

A parcels post system is provided for in the regular postoffice appropriation bill introduced in the house. The measure would apply the foreign mail carrying plan to domestic mail matter and permit the transportation of, 11 pounds of merchandise on rural mail routes on a graduated scale ranging from five cents a pound for the first pound and two, cents for each additional pound.
