Salem .- In answer to an inquiry from a district attorney of Oregon re garding several phases of the prohibition law effective January 1, 1916, Attorney General Brown holds that in a case wherein the owner of a drug store is not a druggist but employs a registered pharmacist to sell drugs and dispense and compound prescriptions, the pharmacist must execute and file the \$250 bond required by section 2 of chapter 141, general laws of Oregon of 1915, before intoxicating liquor can lawfully be sold at the drug store.
