We have sold over 300,000 Ford cars in the time specified, and profit-sharing checks of \$50 each will be distributed as rapidly as possible after August 15, 1915. Retail purchasers who have not yet mailed us their profit-sharing coupons, properly endorsed, should do so without delay.

Our plan to profit share with retail purchasers of Ford cars during 1914-15 has been most successful. We thoroughly believe in it, but, realizing the uncertainty of conditions generally makes it advisable to defer any announcement of future profit-sharing until a later date.

Liquor Laws Reviewed By Atty. Gen. Brown

On January 1, which is but two weeks away, Oregon's new dry law will go into effect.

Although the Journal published an article some time ago from the able pen of District Attorney Wirtz, we have been asked a number of times about provisions of this law, and herewith reprint some extracts from opinions advanced by Attorney General George M. Brown,

According to the law he says that all saloons will close promptly at midnight on December 31. Every sale of liquor after that hour will be illegal, and each sale will constitute, a separate offense.

On and after the first of the year there are but two legal ways to proceed to procure liquor.

First, alcohol only may be had from the local druggist, after the druggist puts up a \$250 bond to the state that he will not violate the provisions of the law. The purchaser must then sign an affidavit that the alcohol will be ued for mechanical or external purposses only and then the purchaser will be limited to two quart in the period of one month. Doctors may prescribe alcohol only, the prescription to show use to which it will be applied.

The other method is to get shipments of liquor from outside of the state, and these are limited to two quarts of liquor or 24 quarts of beer to an individual or a single family.

Liquor cannot be taken to any public gathering, a dance for example, even for the exclusive use of the individual taking it.

Advertisements of liquor in Oregon, either on billboards, through the mails or in publications will be prohibited.

Fines for violations of these statutes range from \$100 to \$500 for each offense and prison sentence also.

The use of liquor at lodges, cluos or any public place is also prohibited and like penaties imposed.

Good Roads Help Increase Land Values

A contrasting picture of the effect of good reads upon farm prices is painted by a daily newspaper of the grain belt in this manner:

A good farm on a bad road. Nice house, Fine team. High fertility. Seven miles from town. Owner wants to sell, Advertises. Buyer comes. Has plenty of cash, seeking good farm, pleasantly located on highway. Buyer wants a good road to town. Boy in school. Likes to go to plays, lectures, church. Couldn't offer over \$100 an acre and doesn't think he wants the farm at all. No sale.

Same thing, similar farm, similar circumstances, except good, permanent read, good every day in the year. Owner thinking of selling. Same man with cash in hand looking for farm. Conversation hinges on price. Offers \$150. Owner can't see it. Keep edging up \$5 at a time.

it. Keep edging up \$5 at a time. Sale closes at \$200 per acre. Everybody happy.

Not the least important phase of the whole highway agitation is the effect of good roads not only upon farm comforts and contentment, but upon farm prices, says Iowa Homestead. A Missouri farm which had never been priced above \$75 an acre, before the construction of good roads sold within a f. w months after their construction for \$112.50 an acres, the owner admitting the advance in value due solely to the new highway. Such incidents are far from rare. The amount asked for road improvement is large enough at times to stagger us, but there are proofs a-plenty that the returns are not long in coming and that the problem is so large as to call for an expenditrure and a policy
