ELKS MAKE W. S. S. DRIVE

Oregon Elks Will Spend Two Months In Big Drive For \$6,000,000

For two months the Elks of Oregon are going to urge every loyal citizen to invest in War Savings Stamps and Treasury Certificates. The sale of more than \$6,000,000 of such securities is the huge task which has been assumed by some 15,000 members of the antlered herd of Portland. Because of the lack of time no house to house canvass will be made. Nor will any particular time be designated for a drive. Through the medium of letters, personal solicitation, and publicity, the Elks expect to arouse public interest to a sufficient degree that 5,000 men and women of the state will invest to the limit in the securities, subscribing to \$1,000 maturity value, and thus dispose of \$5,000,000 of the quota. The remaining million is expected to be disposed through smaller subscriptions. The War Savings and Treasury Certificates bear interest, are subject to redemption upon ten days' notice, pay a certain maturity value and are not subject to the fluctuations of any market and hence loom as one of the most desirable investments which can be made. Harry G. Allen, President of the Oregon State Elks Association, has just completed a tour of the state, and reports that in every county an organization has been effected to handle the campaign. "Innocentation of the thrift serum," says President Allen, "will be the work of Oregon Elks during the next two months."

CONTRACTOR WORKS ON THE MITCHELL ROAD.

where right-of-way will be cleared, and perhaps some of the rocky points worked down preparatory to opening up with the spring work on a large scale as soon as the weather will permit. Messrs. Elliott and Scoggins have proposed that the County Courts of both Wheeler and Crook and also the Forest Service cooperate with them in an attempt to keep the road between Prineville and Mitchell open all winter. It is probable, therefore, that unless extremely bad weather conditions prevail that this road will be at least passable for horse drawn conveyances all of the year.

The recent storms have been general throughout the Forest, from all sections and reports indicate that snow has been from one to near two feet in depth at the higher elevations. The snows were followed by warm rains and chinook weather which has caused the snow to melt very fast. On account of the extreme dryness of the ground the precipitation was practically all absorbed, which is worth a lot both from a range standpoint for next summer and from the standpoint of irrigation next year. Work on the Crook county section of the Prineville-Mitchell road has been abandoned for the winter. The grading has all been done. However, it is expected that several thousand dollars will be spent on surfacing next spring. Brush resulting from the construction work will be disposed of by the Forestry service yet this fall if weather conditions permit. The present plan is to make a clean burning of all refuse along the roadway and make the Prineville-Mitchell road into one of the prettiest of all drives in this part of the State.

Ranger Freeman, who made Cold Springs Ranger Station at Summit Prairie headquarters during the past summer will move to near Antone, where District Ranger headquarters will be maintained throughout the winter months. This change as in the case of Ranger Blake, has been decided upon for the reason that the Forest users in Mr. Freeman's district can be better served from Antone than from Cold Springs.

Ranger E. W. Donnelly is spending a few days in the local Forestry office. Very soon he will go to Burns, where first business in that section will be attended to during the latter part of November, after which time he will probably return to Prineville for a while.

J. B. Gordon, a member of the District Forester's office in Portland, spent several days at the local Forest headquarters during the past week in connection with the local problems. Mr. Gordon returned to Portland on Monday night.

As a matter of convenience to the stockmen and users of the Forest in the Mitchell section, Ranger G. C. Blake will move to Mitchell during the present month. Mr. Blake will probably remain in Mitchell until the first of May, when he will return to the Beaver Ranger Station. The extremely bad condition of the road between the Ranger Station and Mitchell for a time during the winter months is also an important factor in the decision of Mr. Blake to make headquarters in town during the bad weather period.

REDMOND HIGH DEFEATED

A football game was played between Redmond and Crook County High Schools at Prineville Saturday, Nov. 1. The result was a score of 70 to 0 in favor of the C. C. H. S. MEDICOS MEET TWINS COST MORE

The Central Oregon Medical Society, which comprises the counties of Crook, Jefferson and Deschutes, held its regular quarterly meeting in Prineville Tuesday evening, November 4.

There was an excellent representation of the physicians of all of the towns in the district present. Supper was provided by the local physicians. After the supper Drs. Chas. H. Soll and C. J. Vandervert, both of Bend, read papers which proved highly interesting and instructive. At the business meeting several matters of importance to the profession and to the community were discussed. The subject of the social evil was taken up and it was ordered that the law requiring that all such cases be reported to the health officer should be strictly adhered to. Owing to the increased cost of drugs, surgical supplies and living expenses, it was decided that fees must be advanced and a new fee bill was adopted.

The prices in many instances were raised to conform to existing prices in other things. In the future country calls will be charged for at the rate of \$1.00 per mile, while visits in the city will range from \$2.00 to \$5.00 in price for daylight hours, while night calls will cost from \$5 to \$10. Telephone consultations will cost from \$1.00 to \$5.00, the reduction of fractures will cost from \$10 to \$25.00, while operations of a minor character cost as little as \$5.00 and in the major operations, as much as \$1,000 may be charged under the new fee system. Assisting the stork in the city will be accompanied by a minimum fee of \$25, while twins will necessitate a payment to the family physician in the future ranging upward to \$75.

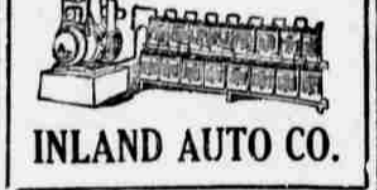
