THIS AGREEMENT WITNESSETH: That I, Frank Bonville, for and in consideration of \$ by these premises do sell and convey, and have sold and conveyed, unto his heirs, executors and assigns, all of my right, title, and interest, both in law and equity, to and in the following described personal asset, property, or estate for and within the corporate limits of the County of in the State of as follows, to-wit: All profit hereafter arising within said County upon royalties derived from corporations organizing under and in conformity to the By-Laws of the Bonville 99-Year System, the Home Office whereof shall be within said County; and the life of this agreement shall be the life of the copyrights secured from the U. S. Government in 1910-11-12, and good for twenty-eight (28) years from the issuance thereof, covering the subject-matter of the said Bonville 99-Year System.

I, the said Frank Bonville, agree not to sell or assign or otherwise dispose of my interest in said copyrights, of which I am the owner, during the lifetime of the same. I further agree to remit to the said all such funds arising from said royalties as foresaid, promptly upon the receipt thereof, following the organization of each and every corporation so organizing within said County under and in conformity to said By-Laws. I further covenant to and with the said that the royalty charge to corporations adopting, using and organizing under the said 99-Year System By-Laws is, and during all the life of this contract shall be as follows: One per cent for the first half million dollars and over that amount one-half of one per cent.
