A good resolution for all business men to make at the first of the coming year is to positively decide that they will during the entire year run an advertisement in the St. Johns Review. It has been agreed upon by the leading business men of the country that every business man, to get the best results, should expend two per cent of his gross receipts in advertising. If every merchant in St. Johns should do this, what a busy business place it would become. The leading stores of Portland spend two or more per cent of their receipts in advertising. That is the reason they are leading stores. Their two per cent in advertising draws trade from those places where the local merchants refuse or neglect to spend two per cent in like manner. So if you want to keep the trade that rightfully belongs here do your bit by laying aside two per cent for advertising. The result will amaze. If two per cent is too strong to take at first, try one per cent. Advertising takes much trade to Portland and advertising in rebuttal will keep it here. Advertising is the keynote of success, and oftentimes is the difference between success and failure. Start the New Year right. Plan your new year advertising early.

The crying need of the hour still seems to be more houses in St. Johns for tenant purposes. It is really pathetic to have people come into this office, as they do quite frequently, and say that they have made the rounds of the real estate offices and followed down every "clue" that they had intimation of in an endeavor to find suitable habitation. Worn and discouraged in their search, they come to the Review office as a "last resort." But we are just as much at sea. We do not know of a single house, modern or otherwise, that may be rented for housekeeping purposes at the present time. Were the houses available it is safe to say that the population of St. Johns would be doubled inside of one year. Rents have gone up quite rapidly, some modern houses renting for \$22.50 per month, which is good interest on the investment. The only solution seems to be for those wanting houses to build them themselves. Land may still be purchased at a reasonable rate, and building material is probably as low in price at present as it will be for several years to come. If every owner of a vacant lot in St. Johns would arrange to have a dwelling erected thereon, it would relieve the tension immeasurably and at the same time prove a profitable investment. It is said to be no difficult matter to secure funds for building purposes when the lot is clear of debt. Therefore, vacant property owners, why not build?

### A Fatal Accident

A fatal accident took place on Fessenden street at Oswego at about 9 o'clock this Thursday morning. J. H. Smith was driving the big new truck of J. R. Weimer, which he had brought from Holbrook loaded with furniture belonging to Mail Carrier E. R. Rowe, who was having his household furniture removed from Holbrook to Swenson street. On the truck at the time, besides the driver, were Mrs. Rowe and her little daughter, and Wm. Rowe, an uncle of Mrs. Rowe. Mrs. Rowe and little girl were in the fore part of the truck, while the uncle was at the rear end watching the furniture. The driver was turning off Fessenden street onto Oswego, and had gotten part way across the track when the street car struck the truck. Owing to the dense fog prevailing at the time the driver was unable to see the oncoming cars, nor did he hear any signal given. The impact carried the truck some distance along the track, killing Wm. Rowe almost instantly, while Mr. Smith and Mrs. Rowe escaped with slight scratches, and the baby was apparently uninjured, we understand. The truck was badly demolished and the household furniture was smashed and strewn along for some distance.
