This fire started when sparks created by an employee grinding reached flammable liquids in the spray booth. Damage is estimated at \$500,000.

On 1/27/2015 at 7:54AM a fire broke out in a spray booth at a semi-truck manufacturing plant. Arriving firefighters found fire burning in the spray booth and above spreading onto the building's roof. The fire forced hundreds of employees to evacuate and numerous plant operations were put on hold. All employees were accounted for and no injuries were associated with this fire. The fire involved flammable liquids and aerosols. Several systems had to

be shut down before the fire could be extinguished. The fire was extinguished and firefighters let employees back into safe portions of the building.

TRUCK SMASHES INTO CONCORDIA WALGREEN'S IN ATTEMPTS TO STEAL ATM

On Tuesday January 27, 2015, at 4:13 a.m., North Precinct officers responded to the report of an ATM theft in progress at the Walgreen's store, located at 5420 Northeast 33rd Avenue. As officers were still en route, witnesses told 9-1-1 that two men ran from the truck, which was stuck inside the store.

Officers arrived in the area and established a neighborhood perimeter and called for a Police K-9 Unit to respond to the scene. Officers went inside the store and located the truck and a chain wrapped around an ATM. Several officers, including the K-9, searched the neighborhood but did not locate anyone matching the suspects descriptions. Both suspects were described as white males in dark clothing. At this time, it is not known if this attempted ATM theft is connected with other reports over the past few months. ROBBERY AT MILL PARK SUBWAY

On Monday January 26, 2015, at 2:56 a.m., East Precinct officers responded to the report of a robbery at Subway, located at 2411 Southeast 122nd Avenue. Officers arrived in the area and spoke to the victim who told police that two men entered the sandwich shop and demanded money. One suspect shoved the victim to the floor during the robbery. After obtaining an undisclosed amount of cash, the suspects fled the store. Several officers checked the area but did not locate anyone matching the suspects descriptions. GUN, METH, CASH AND STOLEN PROPERTY SEIZED FROM LENTS HOME

On Friday January 23, 2015, at 3:29 p.m., East Precinct officers responded to a residence at 9126 Southeast Insley Street on the re-

port that a man menaced two people with a handgun inside the home. Officers arrived and spoke with the victim and his girlfriend, both of whom were menaced by the suspect, identified as 52-year-old James Edwards Stebbins. Officers surrounded the home and called into Stebbins, using a police car PA system, and asked that he come outside the home. At approximately 5:00 p.m., Stebbins exited the home and surrendered to police without incident. Officers assigned to the Gun Task Force (GTF) responded and obtained a search warrant for the home. Once inside, officers located and seized three (3) ounces of Methamphetamine, a small amount of Heroin, a stolen handgun, more than \$4,000 cash, and other stolen property. Stebbins was booked into the Multnomah County Jail on charges of Felon in Possession of a Firearm, Unlawful Use of a Weapon (two counts), Aggravated Theft in the First Degree, and Menacing (two counts).

THREE EARLY MORNING SHOOTINGS - NO KNOWN GUNSHOT VICTIMS

In the early morning hours of Saturday January 24, 2015, Portland Police officers responded to and investigated three separate shooting reports. No gunshot victims were located and no arrests have been made. Anyone with information about any of these incidents should report it to the Police Non-Emergency line at (503) 823-3333 or CrimeTips@portlandoregon.gov.

At 12:22 a.m., East Precinct and Gang Enforcement Team officers responded to the report of a large fight and shooting outside the Mitchell Court Apartments, located at 5214 Southeast 72nd Avenue. Several officers arrived in the area and located evidence of gunfire

outside the apartments. Multiple people were contacted at the scene by police but were uncooperative and refused to assist in the investigation. Occupants of one apartment were contacted and an adult male was discovered to have injuries from an assault but was uncooperative. He was transported to a Portland hospital for treatment to non-life-threatening injuries. No suspects were identified and no arrests were made during this incident.

At 1:25 a.m., East Precinct and Gang Enforcement Team officers responded to a residence in the 9900 block of Northeast Reedway Street on the report of a large fight in the street and that a female was hit by a car that sped away. Officers arrived in the area and contacted the female hit and run victim, who was not seriously injured. She refused to cooperate with police and was transported to a Portland hospital for treatment. A possible suspect vehicle was located nearby and towed for Traffic Investigators.

While officers were conducting this investigation, they heard several gunshots being fired near them, just to the East of their location. Officers immediately responded to Southeast 103rd Avenue and Reedway Street and located evidence of gunfire but did not locate any victims or property damage. Witnesses described hearing vehicles leaving the area immediately after the gunshots.

At 2:02 a.m., North Precinct officers responded to Jag's Clubhouse, located at 605 North Columbia Boulevard, on the report of a shooting and cars speeding out of the area. Officers arrived at the scene and located evidence of gunfire in the parking lot next to the bar. No gunshot victims or property damage was located. Officers spoke with witnesses and learned that the shooting may have been part of domestic disturbance between a man and a woman, neither of whom remained at the scene. The woman left in one vehicle and the suspect left in another.

SHOOTING OUTSIDE LLOYD CENTER MALL

On Saturday January 24, 2015, at 4:43 p.m., North Precinct and Gang Enforcement Team officers responded to the report of gunshots heard in the Lloyd Center Mall parking structure, near Northeast 9th Avenue and Halsey Street. Several officers arrived and immediately entered the parking structure to address any possible threats or suspects and to prevent access to the interior of the mall. Officers did not locate any suspects at the scene and it appears there is no immediate risk to mall patrons. Evidence of gunfire was located near the Barnes and Noble store on the Halsey side of the mall. One window at Barnes and Noble was damaged but it is not clear if the damage is the result of gunfire. A person was seen running out of the parking structure and was described as an African American male wearing all dark clothing, bright-colored shoes, 5'7" tall, cornrowed or dread-locked hair, last seen running northbound on Halsey from the parking structure. It is not known if this person is a witness, suspect or victim. Anyone with information is asked to call the Police Non-Emergency Line at (503) 823-3333.
