Officers, medical personnel and firefighters arrived at the scene and discovered one fatality and one person seriously injured. The driver killed was 37-year-old Jared Daniel Mack of North Portland. He was driving a red 1999 Ford E-350 van. The tractor trailer driver that was critically injured is 54-year-old Mike Robertson Harp of Tillamook, Oregon. He was driving a 1999 International tractor pulling a 1995 trailer full of US Mail. Harp drives for Dill Star Routes, which contracts with the US Postal Service. Investigators learned that Mack was driving westbound on Columbia Boulevard. Witnesses described his driving as erratic and that he was driving in the middle turn lane before crossing over into the eastbound lanes where he struck Harp's vehicle head-on. Based on the investigation, officers believe speed (driving) and alcohol are likely factors in this crash.

SEVERAL GUNSHOTS FIRED INTO HUMBOLDT NEIGHBORHOOD DUPLEX

On Sunday May 17, 2015, at 3:17 a.m., North Precinct officers responded to the report of gunshots fired into a home in the 800 block of Northeast Webster Street. Officers arrived in the area and contacted the residents of the duplex

and learned that nobody in either unit was injured. Several bullets penetrated the walls of both halves of the duplex and evidence of gunfire was found in the street in front of the home. At this time there is no suspect information. The Portland Police Bureau Gang Enforcement Team and Gun Task Force are continuing to actively investigate gang and gun crimes in the City of Portland.

On Thursday May 7, 2015, at 10:24 p.m., North Precinct and Gang Enforcement Team officers responded to the Humboldt Garden Apartments, located at 220 North Sumner Street, on the report of multiple gunshots fired into a residence. Officers arrived in the area and contacted the victim who told police that she saw two African American males outside her door right before the shots were fired into her home. Another witness saw the suspect running northbound through the neighborhood after the shooting. Both suspects were wearing gray hoodies and had their faces covered. There were no injuries in this shooting. On Wednesday May 6, at 11:33 p.m., a suspected fired multiple rounds at a group of people sitting outside the same residence but did

not hit anyone. Gang Enforcement Team investigators believe the two shootings are related. Anyone with information about gang and/or gun crimes in the City of Portland is encouraged to provide information to the Portland Police Bureau's Tactical Operations Division at (503) 823-4106.

GANG ENFORCEMENT OFFICERS ARREST 17-YEAR-OLD AFTER FOOT PURSUIT, SEIZE HANDGUN

On Wednesday May 6, 2015, at 5:11 p.m., Gang Enforcement Team (GET) officers were patrolling the area of North Albina Avenue and Killingsworth Street when they saw a two groups of African American male teens in the intersection involved in an argument while blocking traffic. One of the teens, later identified as 17-year-old Jordan Louis, reached for his waistband as soon as officers pulled up to the intersection. Other teens in the group yelled "no" and "police" at Louis. Louis saw the police and took off running as officers exited their patrol car and began to pursue him, believing him to be armed based on their observations. As Louis ran from officers he dropped a handgun onto the ground, picked it up and continued running. Additional Gang Enforcement and North Precinct officers responded to the area and set up a neighborhood perimeter. Officers located and
