

PORTLAND FIRE PULLS A MAN FROM WILLAMETTE RIVER

News Release from Portland Fire & Rescue FlashAlert: July 12th, 2015 6:05 PM At 4:36 PM, Portland Fire responded to reports that a man had jumped off the Waterfront Seawall and was in the Willamette River, clinging to a boat just south of the Steel Bridge on the west side of the river. Within just a few minutes, Rescue Craft 1 from Station 1 arrived and loaded the man onto the rescue craft. They then transported him to the Portland Fire dock at Station 21, which is at the east end of the Hawthorne Bridge. The man was loaded onto an ambulance and transported

to Emanuel Hospital for evaluation. In addition to the fireboats that Portland Fire operates, they have two "Rescue Crafts", which are fast, highly maneuverable Sea-Doo watercraft. They carry a boat operator and a rescue swimmer. These rapid-deployment vessels provide for a timely response and can often get rescuers to the scene within minutes of being deployed.

10 VEHICLES DAMAGED BY BB GUNS - TWO ARRESTED

News Release from Portland Police Bureau FlashAlert: July 7th, 2015 1:00 PM On Monday July 6, 2015, at 9:42 p.m., North Precinct officers responded to the area of N Greeley Ave and Dekum St after a caller reported a possible drive-by shooting. Officers arrived in the area and located 10 vehicles in the immediate area that had damage caused by a BB gun. Witnesses provided suspect vehicle information as a gray or silver Mercedes SUV. At 10:35 p.m., a North Precinct officer spotted a vehicle matching the suspect's description in the 4400 block of N Vancouver Avenue. The officer stopped the driver and occupants and discovered open CO2 cartridges and BB pellets inside the vehicle. During the investigation, a BB rifle and three BB handguns were seized from the

> vehicle. Two of the three occupants were arrested and charged with Criminal Mischief in the First Degree and Discharge of a Firearm in the City. 18-year-old Daniel Bernard Piehl was booked into the Multnomah County jail and 17-year-old Marcus Paul Raiford was lodged at the Donald E. Long Juvenile Detention Home.

On Friday July 3, 2015, at 5:50 a.m., North Precinct officers responded to the report of an armed robbery at the Plaid Pantry, located at 2730 North Lombard Street. Officers arrived in the area and contacted employees who told police that the suspect entered the business, pointed a handgun at the clerk, and obtained an undisclosed amount of money before leaving the store without incident. Several officers, including a Police K-9, searched the neighborhood but did not locate anyone matching the suspect's description. The suspect is described as an African American male, 5'7" tall, thin build, wearing dark-colored shorts, a light-colored t-shirt, and a knit cap. 33-YEAR-OLD MAN AR-**RESTED FRIDAY IN CON-NECTION WITH JUNE 2015** SHOOTING

On Friday evening July 3, 2015, Portland Police Bureau Gang Enforcement Team (GET) officers stopped a vehicle at Northeast 27th Ave and Emerson St associated with a shooting that occurred in June 2015. The driver, 33-year-old Joshua Kerr Gann, was arrested and interviewed by GET detectives investigating the shooting. Gann was booked into the Multnomah County Jail on charges of Felon in Possession of a Firearm, Unlawful Use of a Weapon and Carrying a Loaded Firearm within City Limits. This investigation started on June 10, 2015, at 10:54 p.m., when North Precinct officers responded to the area of North Ainsworth Street and Commercial Avenue on the report of gunshots and a vehicle speeding out of the area. GET officers and detectives developed witness information in the case, leading to Gann's arrest.
