MAN EXPOSES HIMSELF TO 10-YEAR-OLD GIRL IN ARBOR LODGE

On Tuesday September 8, 2015, at 3:51 p.m., North Precinct officers responded to the report that a man exposed himself to a 10-year-old girl in the area of North Denver Avenue and Bryant Street. Officers spoke with the girl and her mother and learned that the girl was walking home from Chief Joseph School, located at 2409 North Saratoga Street, when she was contacted by a man riding a bicycle. The suspect asked her some questions then exposed his penis to her as he rode his bicycle. The girl ran home and told her mother, who called police. The suspect is described as a white male in his 30s, medium to thin build, brown hair, mustache, wearing a blue t-shirt, blue baseball hat, shorts, and black athletic shoes. The bicycle was described as a mountain bike with a rack and saddlebags. Several officers checked the area but did not locate anyone matching the suspect's description. There is an unconfirmed report that a similar incident happened today near De La Salle North Catholic High School, located at 7528 North Fenwick Avenue, in the Kenton Neighborhood. If any residents in the area of this incident have residential surveillance cameras, investigators are asking them to check recordings for any possible images of the suspect.
