DETECTIVES CONDUCT A DEATH INVESTIGATION IN NORTH PORTLAND

On Monday October 5, 2015, at 7:22 p.m., North Precinct officers responded to the 5500 block of North Columbia Court to conduct a welfare check of man found bleeding outside a building. Officers and medical personnel arrived and located the male victim suffering from traumatic injuries. Medical personnel were unable to save the man and he died at the scene. The victim has been identified as 33-year-old Gerardo Granados-Marin. The Medical Examiner determined that he suffered multiple sharp force injuries and ruled his death a homicide.

THREE ARRESTED, THREE GUNS SEIZED

On Saturday October 3, 2015, at 5:39 p.m., Gang Enforcement Team (GET) and Transit Police Division officers were patrolling the area of Woodlawn Park in Northeast Portland when they

contacted the occupants of a car parked at Northeast Claremont Avenue and Dekum Street. As officers were walking up to the car they heard the sound of metal hitting the sidewalk. Concerned that someone in the car dropped a gun out of the vehicle; officers took cover and ordered the occupants out of the vehicle at gunpoint. Three young men exited the vehicle and were taken into custody without incident. During a search, one of the men (18-year-old Leontrell Robert Mitchell) had a gun in his possession. Officers then approached the vehicle and noted two handguns lying outside the passenger side door. 18-year-old Marshall Charles Richmond Jr. was booked into the Multnomah County Jail on charges of Felon in Possession of a Firearm, Possession of a Loaded Firearm and Unlawful Possession of a Firearm. 18-year-old Timothy Wayne Wilson was booked into the Multnomah County Jail on charges of Felon in Possession of a Firearm (two counts), Unlawful Possession of a Firearm (two counts), and Possession of a Loaded Firearm (two counts). Mitchell was

booked into the Multnomah County Jail on charges of Unlawful Possession of a Firearm and Possession of a Loaded Firearm.

SHOOTING AT GANG-RELATED PARTY ON HAYDEN ISLAND - TWO GUNSHOT VICTIMS

On Sunday October 4, 2015, at 12:08 a.m., North Precinct and Gang Enforcement Team (GET) officers responded to the report of a shooting with multiple victims at the Red Lion Jantzen Beach Hotel, located at 909 North Hayden Island Drive. Two victims were injured. Both female victims were transported to Portland hospitals for treatment and are expected to survive. The suspect or suspects fired multiple rounds from outside the hotel, striking the building numerous times. Five hotel rooms were determined to be part of the crime scene. Preliminary information indicates that there was a large group of gang members and associates at the hotel for a party. The suspect was outside the hotel and fired several shots before fleeing

the area. Several vehicles left the scene but at this time there is no specific suspect information. Officers have received unconfirmed information of additional victims that may have left the scene. Officers entered the hotel and found evidence of a shooting and several rooms impacted by gunfire. Additional officers from Central and East Precincts, as well as the Air Support Unit responded to assist with the investigation. Anyone with non-emergency information about this shooting is asked to call the Police Non-Emergency Line at 503-823-3333.

The Tactical Operations Division is continuing to investigate several incidents of gun violence citywide. Anyone with information about gun crimes in the City of Portland is encouraged to provide information to the Portland Police Bureau's Tactical Operations Division at 503-823-4106 or email information to gangs@portlandoregon.gov. Information learned from social media sites such as Facebook, Twitter or YouTube should be shared with investigators as these tips may lead to the identification of a suspect or suspects. The Portland Police Bureau works closely with Enough is Enough PDX, a community-led campaign aimed at encouraging people to take a stand against gang violence in the area. CHILD STRUCK ON NORTH LOMBARD STREET

On Friday October 2, 2015, at 8:24 a.m., North Precinct officers responded to the report of a child struck by a driver in a vehicle in the 3200 block of North Lombard Street. Officers and medical personnel arrived and began treating the child, estimated to be an 11-year-old girl. The child was transported to a Portland hospital with traumatic injuries. The involved driver remained at the scene and is cooperating with investigators. The Traffic Division's Major Crash Team is responding to conduct an investigation.

The injured child remains at a Portland hospital and is expected to survive her injuries. Investigators learned that the child got off of an eastbound TriMet bus and ran northbound across Lombard where she was hit by a westbound driver who was unable to stop in time. No citations have been issued and the case remains under investigation.
