We think we can control this matter how-ever, by excluding, if it becomes nec-essary, all outside pupils and admit-ting only those of our own district. Our estimate for janitors is increased

\$50 over last year, as we found that we could not get a satisfactory man for the Eastham building for less than \$35 per 7 to 5. month.

Cord wood has advanced in price. and a new furnace will have to be placed in the Eastham building. Some blackboard repairs will have to be made, etc.

We estimate that our floating indebtedness at the end of the fiscal year will be \$1500, that with the other items will be \$10,700, which will have to be provided for during the year. As there will be no material change in school population from last year, we estimate our receipts from the county apportionment to be \$4 000, and from the state \$1450, making a total of \$5,450.

If we do get the estimated amount there will still be a shortage of \$5,250, which will have to be raised by special tax. The county clerk reports the taxable property in the district to be \$635,-436, or \$192,304 less than last year.






