BOARD OF COMMISSIONERS. Regular November Term of the County Board.

J. B. Morton, John Lewellen and T. B. Killin, Commissioners.

In the matter of the application of Wm Harris for improvement of Oregon City and Linn Mill road:
It is ordered that William Harris be authorized to lay 25,000 feet of plank on the Oregon City and Linn Mill road and that he receive \$2 per M thereof when so laid.

In the matter of highwaymen in Milwaukie and Oswego precincts:
It appearing to the Board that numerous persons have been held up and robbed on the public highway in Milwaukie and Oswego precincts, and that the said robber or robbers have successfully eluded the officers of the law. It is ordered that the sheriff be authorized to offer a reward of \$100 for the arrest and conviction of the person or persons engaged in said robbery.

In the matter of the Moechnke and Beason road in Road District No 18:
It is ordered that Supervisor Daniels of Road District, No 18, be and hereby is authorized to appoint Fred Moechnke as Deputy Road Supervisor in said district, said deputy to supervise the grading of the Moechnke and Beason road in said district.

In the matter of the application of William Rider for improvement of Rider Hill:
On application of William Rider for the improvement of Rider Hill, it is ordered that Clackamas County furnish 2000 Corduroy, provided the people in the vicinity of said hill volunteer and lay the same.

In the matter of the application of J. H. Honebone for improvement of the Davis road:
On application of J. H. Honebone for improvement of the Davis road, it is ordered that Clackamas County furnish 4000 feet of lumber for said road, provided the people in the vicinity furnish an equal amount and lay all.

In the matter of report of John Heinz, supervisor of Road District, No 25:
It appearing to the Board that this report was laid over from the November term for the reason that said supervisor had not complied with the orders of this Board, and now on this date, the Board being fully advised, it is ordered that said report be allowed in full and that the amount of said report paid out of Road Fund be taken from the apportionment of said district in 1902.

In the matter of report of W. H. Counsell, supervisor Road District, No 1:
It appearing to the Board that this report was laid over at the November term for the reason that said supervisor had not complied with the orders of this Board, and now on this date, the Board being fully advised, it is ordered that said report be allowed in full and that

the amount of said report paid out of Road Fund be taken from the apportionment of said district in 1902.

In the matter of petition of Elizabeth Heitkemper for vacation of part of Third Avenue, Oak Grove:
Now comes on to be heard the petition of Elizabeth Heitkemper, praying to the Board to vacate that part of Third Avenue which lies North of the line between lots 4 and 5 of Tract 94, Oak Grove, as the same is laid out. And it appearing to the Board that a remonstrance to said petition has been filed with this Board, it is therefore ordered that said petition be laid over until Jan. 3rd, 1902, at 10 o'clock a. m.

In the matter of care and keeping of Abraham Yates, a county charge:
It appearing to the Board for the month of December, 1901, E. N. Foster was entitled to \$6 00 for the care and keeping of said county charge, and no warrant has been drawn therefor, and it further appearing that said E. N. Foster has drawn \$6 00 on account of said county charge for the month of November, 1901, and that he was only entitled to two-thirds of said amount, or \$4 00, it is ordered that a warrant be drawn in favor of E. N. Foster for \$4 00, and that Abraham Yates receive no further aid from Clackamas County.

In the matter of warrants drawn for county charges:
It is ordered that the names of county charges be published each month in connection with warrants for care and keeping of said county charges.

In the matter of the J. R. Lewis County Road:
It appearing from the petition of A. Hayhurst and the showing made in relation thereto that the true location of the J. R. Lewis County Road where it runs between the Donation Land Claims of C. F. Beatie and Jephtha May is in doubt and that the fencing along this road between these claims is obstructing said road, and this Board being unable to make the proper order in relation thereto without being further informed as to the facts, it is therefore ordered that the County Surveyor be and is hereby directed to make an examination and a survey of said J. R. Lewis road where it runs between said Donation Land Claims of C. F. Beatie and Jephtha May and to determine the township line on the south boundary of Tp 3 S, R 2 E, where it runs between Section 34, in Tp 3 S, R 2 E, and Section 3 in Tp 4 S, R 2 E, and to determine the South boundary of the C. F. Beatie D. L. O., and to determine the North line of the Jephtha May D. L. C., and to map said claims in relation to said county road and also to mark out on said map or plat the line of the travelled road between these two claims, and the location of the fences on both sides of said road along these two claims, and to show the date of the respective surveys of the township and claim lines in relation to said claims and to bring said report or plat or map to this Board before the next session thereof, and it is so ordered.

In the matter of petition of O. S. Philips and wife:
Now comes W. H. Mattoon and presents to the Board a petition signed by 13 citizens of his neighborhood asking the board to grant assistance to Mr. and Mrs. Philips, and the board being fully advised, it is ordered that O. S. Philips, and wife have aid in the sum of \$5 per month from November 1, 1901 and that warrant be drawn in favor of W. H. Mattoon.

In the matter of improvement of the Barlow and Cascade road:
On application F. E. Siborgie, it is ordered that Clackamas County furnish 2000 corduroy for the Barlow and Cascade road.

In the matter of the petition of Stephen A. D. Hungate, to declare the Molalla River a public highway:
Now comes on to be heard the petition of Stephen A. D. Hungate, showing to the Board that on the 24th day of December, 1901, he filed with the clerk of Clackamas County, his written declaration for the exclusive right to regulate, manage and control the floating, transportation and booming of logs, lumber, timber and wood upon the Molalla river, and such tributaries hereto as is hereafter set forth, together with the field notes, map and certificate of the surveyor as required, and he was en-

NEWS OF THE WEEK.

Friday, December 27

Governor Governor John R. Rogers died yesterday evening at Olympia, the Washington state capitol, after a lingering illness of six days. In the morning he began to sink and passed into a comatose state. He grew steadily weaker through the entire day. The collapse was a surprise to his family and physician, as he had rested better during the previous night. Mr. Rogers and the Governor's two daughters, Mrs. Blackmah and Miss Helen Rogers were at his bedside all day. The Governor's son, Edwin Rogers, who is in London, was cabled, and F. J. Rogers, the Stenford professor, and A. C. Rogers, of Santa Barbara, were sent for. Governor Rogers died. Governor Rogers will be succeeded by Lieutenant-Governor McBride, who was elected on the republican ticket. John R. Rogers was a native of Maine, born in 1834, and from an obscure druggist at Poyallup, rose to be governor of Washington. In Kansas he engaged in farming, and also conducted a drug store. He was active in organizing the farmers' alliance, and was editor of the Kansas Commoner for several years at Wichita, during which time he held several minor offices. He was the author of several works on political economy, written in an incisive style. He was elected as a member of the Washington legislature in 1894 as a populist. In the memorable three-cornered convention held at Ellensburg in August, 1893, he was nominated for governor on the fusion ticket, after one of the greatest political struggles in the history of the state. He was elected by a large majority, defeating F. B. Sullivan, the republican nominee, of Tacoma. In September, 1900, he was renominated by the fusionists at Seattle, and re-elected by 2000 majority, defeating State Senator J. M. Flink. Governor Rogers was not what would be called a politician, but of the seven times he was a candidate for office, he was never defeated. He was upright and honest, and no matter whom he crossed, he spoke his sentiments, and put them into practice as far as was in his power. He was a true friend, but a bitter political foe. He instituted many reforms during his term of office, and was generally regarded as a successful governor.

Germany's A dispatch from Washington states that the gathering of German warships in the vicinity of Venezuela and the presence in the same locality of so many American, British, French and other warships is directing attention to the immense naval demonstration Germany is about to make against Venezuela. Thus far Germany has not made public the exact detail of her proposed move, the official communication to the United States being confined to an inquiry as to the attitude of this government on the question of a demonstration, in view of a purpose on the part of Germany not to acquire any permanent foothold in Venezuela. The answer of this government was entirely satisfactory to the German authorities, who have since proceeded with their plans for coercing Venezuela.

The Dalles-Celilo canal project is better in favor than ever before.

United States Senator William J. Sewell died at Camden, N. J., yesterday.

Governor Rogers' death was due to worry over state matters as much as illness.

Acting Governor Henry G. McBride will take the oath of office today as governor of Washington.

The body of London, the Coos county murderer, lies buried in Benton county, so claims the murderer's brother.

Nine ships are believed to have been lost in Challein bay, Puget Sound.

Southern California suffers a severe loss from a heavy wind and sand storm. Many oranges were blown from trees and whole orchards devastated.

PROBATE COURT.

Judge Ryan Made Several Orders During the Week.

Charles Spencer, W. L. Midlam and George Quinn were appointed appraisers of the estate of Reza May, a minor, W. D. Bowers, guardian.

Casper Weismandel, Nathan Moody and Philip Graves were appointed appraisers of the estate of Anton Klar, deceased, E. A. Klar administrator.

David Knowlton aged 14, was committed to the state reform school Tuesday.

The will of the late Sue McKee was admitted to probate Tuesday. The will bears the date of April 8th, 1901, and the subscribing witnesses were Henry Gilbert and K. S. Latourette. The instrument provides that the property, real and personal, be converted into cash. After the funeral expenses are paid, the remainder is to be placed at interest during the life time of her mother, Theresa Baker, the interest to be paid in equal shares to the mother and the deceased's two sisters, Martha and Ida B. Blankenship. After Mrs. Baker's death, the property will go to the sisters and their heirs. B. F. Baker and H. Blankenship are named as executors of the will, but as the former recently died, the trust devolves on H. Blankenship, whose appointment was confirmed by the court. The appraisers of the estate were Henry Gilbert, F. J. Meyer and J. G. Porter, and the appraisal valuation is \$577.
