REPUBLICAN CANDIDATES.

Brief Sketches of Those Who Seek Suffrages from Voters.

SENATOR GEORGE C. BROWNELL.

Candidate for re-nomination, was born in New York state in 1858, where he studied law and was admitted to the bar at the age of 21 years. He then moved to Kansas, where he was general attorney for the Atchinson & Nebraska railroad, and was elected mayor of Frankfort, Kan., in 1884 and re-elected in 1885. The following year he was appointed attorney for Fitzgerald-Mellory Construction Co., which built 1000 miles of railroad through Kansas and Colorado. In 1888 he was elected attorney of Ness county, Kan., and in 1891 he came to Oregon and located in Oregon City. The following March the republican party tendered him the nomination for state senator, which he declined, but was made chairman of convention and central committee. In 1894 Mr. Brownell was nominated by acclamation and elected over Hon. W. A. Starkweather. Again



WILLIAM BROBST,

Candidate for county commissioner, is a resident of Wilsonville, on the West side, and is a prosperous farmer.

JUDGE THOMAS F. RYAN,

Candidate for re-election, is a native of Rhode Island and was educated in the public schools of Providence, R. I., and Holyoke, Mass. On leaving school he was engaged in the woolen manufacturing business until 1878, when he went to Colorado and engaged in mining for a year after which he was traveling correspondent for the Boston Journal until he came to Oregon in 1880 under contract with the Brownsville woolen mills. In 1881 he came to Oregon City and accepted a position with the Oregon City Manufacturing Company, and in 1885 he purchased the Cliff House, which he conducted successfully for four years. In 1888, he and T. P. Randall engaged in



In 1893, he was nominated by acclamation and elected, defeating Hon. W. S. U'Ren. In 1899 the republican county convention endorsed him for congressman. He is as well known as any other resident of this county, and is a good campaigner and orator. In accepting the nomination for the third time he said he would work for an eight-hour labor day, three-cent railroad fare, precinct assessors, and so on. He claims to have been instrumental in passing the six-per-cent interest law, road supervisor election law, 30-day exemption law etc.

C. G. HUNTLEY,

Candidate for representative, is a native of Michigan, and came to Oregon City in 1890, and entered into partnership with E. G. Canfield in the drug business. After one year Mr. Canfield severed his connection with the firm and went into the banking business. Mr. Huntley has successfully conducted the business for the past 12 years. Last spring he was appointed by the governor to serve five years on the state board of pharmacy, which speaks well for his business qualifications. He has been elected councilman for two terms and is at present president of the Oregon City council.



HERMAN A. WEBSTER,

Of Clackamas precinct, candidate for representative, was born in 1872 in Illinois, from whence he came to Oregon in 1881. He received his education in Portland and at Stanford University, and studied law in the office of A. S. Dresser, of Oregon City, and was admitted to the bar in 1900, but has not practiced regularly. He has been justice of the peace of Clackamas and Milwaukie precincts for four years. He married Hattie E. Davis in 1898.

JOHN W. WELDRUM,

Candidate for surveyor, is a native of Iowa and came to Oregon in 1845. He



took up surveying in 1865 and has followed that occupation since and has no doubt run more lines than any other man in Oregon. He was surveyor of Clackamas county from 1888 to 1890 and judge from 1890 to 1894 and has been deputy surveyor since 1897, a position he now holds.

R. L. HOLMAN,

Candidate for coroner, is a native son, having been born in McMinnville in 1865. He came to Oregon City in 1890 and engaged in the furniture and undertaking business with E. S. Warren. He has been in the undertaking and casket business ever since. Mr. Holman has been coroner two terms, having been elected in 1892 and 1894.

TOM P. RANDAL,

Secretary of Central Committee, is a native son of Clackamas county and possessed of thorough business qualifications, and we expect, as far as he is concerned, a clean and honest campaign.



He is now serving his second term as recorder of Clackamas county.

JOHN R. SHAYER,

candidate for sheriff, is a native son and was born near Silverton, Marion county, his father being a pioneer of 1851. Before moving to his present place of residence he conducted a livery stable in Portland for three years, and was elected assessor of East Portland for two years. In his precinct he has been supervisor for three terms, school director for three terms and constable for two terms. He is one of the most promising stockraisers and stockbuyers of Clackamas county. On his ranch he has over 25 head of fullbred Herefords. His father and brothers are owners of the Shaver steamboat line on the Columbia.

HENRY E. STEVENS,

Candidate for recorder, is a native son of Clackamas county, having been born in Canemah in 1865. He has always lived in this county, for the past eight years at Milwaukie, where he married. He was educated in the public schools of Oregon City and Portland business college. Mr. Stevens was deputy clerk under H. H. Johnson and deputy recorder under W. T. Whitlock. For the past five years he has been conductor on the electric line between Oregon City and Portland.

F. A. SLEIGHT,

of Canby, candidate for county clerk, came to Oregon City from Rockford, Ill., in 1889. He was one of the incorporators of the Oregon City cannery, and was bookkeeper and head clerk for E. E. Williams, the erstwhile Oregon City grocer, for five years, before moving to Canby, where he has conducted a fruit farm of 45 acres for over three years. He has been director of his school district, and is at present school clerk.

JAMES F. NELSON,

Candidate for assessor, is a resident of Milk Creek precinct. He was deputy assessor under John Bradley, and is an old soldier.

LOCAL TEACHERS' INSTITUTE.

Entertaining Addresses by Prominent Educators.

About 100 teachers and other interested persons were present at the institute held at the Eastham school building last Saturday under the auspices of the Clackamas County Teachers' Association. The features were several lectures and discussions, the luncheon served by the city teachers, and the musical program presented by the local school pupils.

The program as heretofore printed in this paper was carried out to the letter, as follows:

"Civil Government Our Text," was ably presented by Miss Fannie G. Porter, of Oregon City, the most capable teacher in the failing school in Portland.

"Mathematical Geography," was illustrated in a most capable manner by Miss Sade H. Chase, a prominent teacher in the Oregon City schools.

At the afternoon session Miss K. Alice Quigg, of the Portland Academy, gave an interesting dissertation on "Nature Study in Elementary Schools."

Professor R. O. French, supervisor of the training department in the Month state normal school, gave a very entertaining lecture on "Important Phases of Primary Teaching."

Misses Fannie G. Porter and Miss K. C. McMillan assisted County Superintendent Zinsler in preparing the excellent program. On the whole, it was the most satisfactory teachers' meeting ever held in Oregon City.

The will of the late Joseph Ellis was filed for probate, but the instrument was sent to Wallace, Idaho, to secure the testimony of the subscribing witnesses.

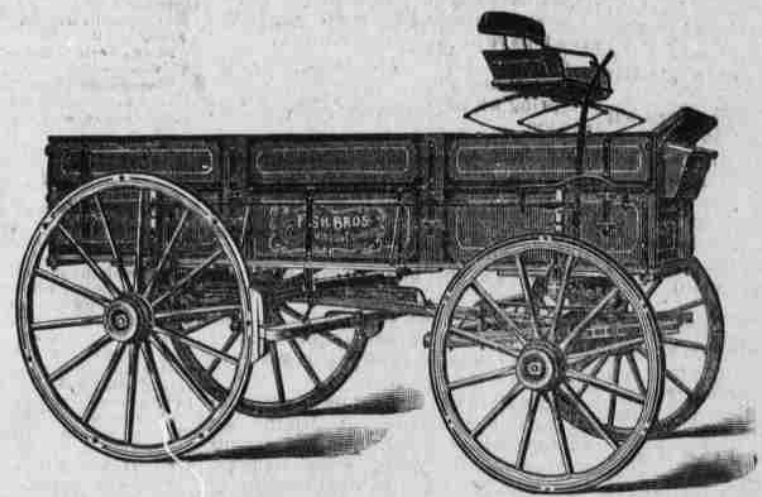

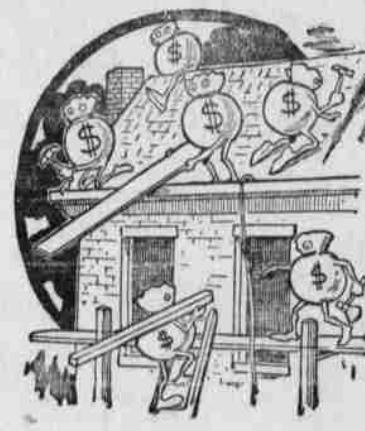
