Groups of convicts lounged about or lay sick and incapacitated on the verandas. At night the barred iron door of each dormitory is locked, and outside paces a guard, revolver in hand.

Many a poor wretch dreads the night hours, and one suspected of informing may be set upon by an enraged pack. Occasionally murder is committed in profound silence, and daylight finds a dead or dying convict in the passageway or entrance.

All the men I talked with were well disposed toward me, one in particular—a tall, well educated man with a pair of dark rimmed glasses and large eyes fearfully strained through inability to secure proper lenses.
