WAR IS SURELY ALL THAT SHERMAN THOUGHT

Local Housekeepers Find that Prices on Contraband Goods Go Soaring

"Give me some of that sugar like I got last week; I guess you might as well make it another sack, please," said the Perfect Lady to her groceryman.

"Yes ma'am, it will be \$7, said the groceryman.

"Seven dollars?" Why I only paid five dollars and twenty cents for that last week, don't you remember? You said that you had just got a carload in from Portland. I used up most of that canning fruit, and I want some more, but I don't see why."

The Groceryman smiled pityingly. "Madam, we are sorry that the price has gone up, but you cannot blame us. This European war has made everything higher, and sugar is seven dollars a sack now. I wish—"

"But this is the same sugar that you got a carload of, isn't it?" protested the Perfect Lady. "And you sold me some of that carload at five dollars. Do you have to pay more for the balance of the carload that is in your warehouse?"

The Groceryman compressed his lips. "Our sugar is now \$7 a sack," was all he said.

Funny, isn't it? War breaks out in Europe. Under the neutrality rules, provisions are contraband, and so cannot be shipped from this country to the warring nations. Yet because of the war we pay 60 cents more for sugar, from two to eight cents a pound more for meat, and shoes are going to be 30 cents a pair more in the future. Yes, that is what they tell us.

Yet the sugar was bought before the war started, most of the meat was killed before the war started, and the shoes were sold to the retailers and paid for long before the war started.

Over in Great Britain, in Germany and France, where the pinch of war really comes, the government has prohibited the raising of prices on foodstuffs, groceries and butchers who try to gouge their patrons who will be shot or imprisoned, the orders say. But here in the far West of the United States, where the war isn't doing anything more than giving us a lot of extra papers to build the fires with, foodstuffs and other necessities leap up in price.

This is an interesting condition of affairs. Pretty soon the prices of guns and cartridges will go up here too. When trade is open to the whole world and when the United States sells to Europe, prices are down. When war breaks out and foodstuffs and things are contraband, and the European trade is cut off, giving a larger supply for home consumption, prices go up.

Can you see the logic of it?

DEATHS

Miss Florence Price, a well known and highly respected young woman of this city, died at the Sellwood Hospital Saturday afternoon, after an illness of several months, her death being due to cancer of the stomach.

Miss Price was an ambitious and bright young woman. She has for several years been owner and proprietor of a restaurant near Fourth and Main streets, and by her obliging manner and charming personality had built up a large patronage. It was several months ago that Miss Price was obliged to give up her duties, owing to ill health, although she had been a sufferer for some time previously, and entered the St. Vincent's Hospital in Portland, where several surgical operations were undergone in the hopes of saving her life, but without avail, and about three weeks ago was removed to the Sellwood Hospital, where she passed away surrounded by her family.

Miss Price, who was born at Hamilton, Lowden County, Virginia, moved to the state of Ohio with her parents, Mr. and Mrs. R. Price, and later came west, first making her home at Salem, and in 1888 came to Oregon City, where she has since made her home.

The deceased is survived by her mother, Mrs. R. Price, of this city, one sister, Mrs. Annie Lance of Sellwood; three brothers, John Price of Eastern Oregon, Milton and Calvin Price of Oregon City. Her father, who was a well known business man of this city, died some time ago, and a brother, Fred Price, met his death in a fire in Portland several years ago.

Many friends attended the funeral services to pay their respects, the services being held at the family residence at 814 Third Street Wednesday afternoon at 2 o'clock, Rev. Jones of Portland, pastor of the Congregational church of that city, officiating, the deceased having united with that denomination when a resident of Salem.

The interment was in the family lot at Mountain View cemetery. The casket was completely hidden by the beautiful floral offerings, among them being offerings from the Rebekah and Artisan Lodges, of which Miss Price was a member. The pallbearers were Grant B. Dimick, Edward McFarland, William Trudell, Arthur Jones, Owen Thomas and M. P. Chapman.

Mrs. Clarence Bruner, who has been critically ill for several months, and who recently underwent a surgical operation at the St. Vincent's Hospital, Portland, died suddenly of heart failure at that institution Saturday afternoon. The funeral services, which were conducted at the home of Mrs. Bruner's parents at West Linn, were largely attended, and many attended the final services at Mountain View cemetery. Rev. FROM A GERMAN VIEWPOINT

Gustav Schmoerr and the Way He Sees the European War Situation

Willamette, Ore. 8-10-14.

Editor Courier:—

In the Enterprise of last Friday is a picture of the Emperor William and ask, "What will he do?" This question is childish. The Kaiser himself could not answer it. The Kaiser as highest official simply does what the Bundesrath, Delegates of each German state, and what the German nation through the majority of its Reichstag may decree. The Kaiser has no more authority, in fact, he has less than the president of our republic. Why does the great majority of the English-American press constantly oppose this great and noble man? Has directly or indirectly English money anything to do with it? It was Kaiser William who hitherto sought the peace of Europe and who alone, through the power of the German nation, maintained it.

War has now broken out, a war that the nations of the world have long expected with fear and trembling but it is not the Kaiser's fault, it is the fault of the Russian aggression and Russian regime. The German nation united with Austria-Hungary was fully convinced through the Russian-Siberian misdeeds, that peace could not be maintained for any length of time with a people among whom murder and injustice are rampant and therefore the German people demanded of its leader that war be declared on this half-civilized, half-barbaric mob, especially because they knew—and Russia admitted that Russia was mobilizing her forces along her boundaries of Germany and Austria-Hungary. England and France were also long prepared for war and were ready to march into Germany through Belgium, Luxembourg and Holland. Now the enemies of Germany are highly offended because Germany took the initiative instead of waiting until the enemy had bound her hand and foot, and they blame the Kaiser for the war. The Kaiser did all in his power, in fact he did more than he should have done, into the very last moment to maintain peace. To prevent war, to secure peace upon the nations, he went to the very limit of his honor as a ruler and also to the very limit of the national honor of his faithful German people.

While the Kaiser, moved by the hypocritical pleadings of the ruler of Russia, sought to secure peace between Austria and Serbia, this autocratic liar in Petersburg broke his promise and forced Germany to declare war, and England and France, those highly civilized countries of Europe, instead of remembering the shameful occurrences in Sarajevo, where Russia was chiefly to blame, and instead of leaving such company, now stand one soul with murderers against one of the most highly civilized, educated Christian nations of Europe. Depend upon it, the time is coming when Protestant England will awfully and deeply rue the fact that she helped Russia, Greek-Catholic and semi-barbarous, to her own detriment. What will England receive of Persia and Tibet if her protestant neighbor Germany, and with Germany Austria, must suffer destruction by overwhelming numbers? Nothing. What would she keep of India and perhaps of Egypt? Likely nothing.

In opposing Germany, England is seeking to destroy that power to which she owes her existence and strength. If Germany is defeated, it would be an easy matter for Russia to execute the last will of Peter the Great, to take the farthest limit of the Bosphorus. That nation, however, that takes these fortresses from the Turk, will be the conqueror of the whole world. Culture and civilization will then suffer for hundreds of years. Do you understand?

What will the Kaiser do? If Germany and Austria win, then will long and deep peace follow this victory. If they lose, then turmoil and arson and murder will not cease. Not only Europe, but Asia, Africa, Australia and the United States will be drawn into butchery in the end humanity will destroy itself. Does England, the land of Bible societies; does America, the land of churches, not read the Revelation?

We should all pray in spirit and in truth that God have mercy on us all and this is what Kaiser William does every day.

Therefore, English-American press cease your clamoring and your ridiculing. The German people and the German Kaiser are like their Bismarck, they fear God but nothing else in the world. Is God with them, who can stand against them?

As an old friend I would ask you to be careful in your remarks on reports of war. The greatest number of German-American citizens in this country desire to know the truth, but they do protest against any insult or slander of the German nation or of their Kaiser and if any paper continues in this hateful spirit, you may be sure that they will cancel their subscription thereto.
