

It is always important to begin the feeding of cattle early in the season Heavy feeding during the last month of the winter period cannot make up for meager feeding in November or December. While it is economy to let the stock run on pasture as late as possible, the supplemental feeding of rough feeds should begin as soon as the pasture fails to supply enough to keep the stock growing.
