## Poison the Field Mice.

Many berry growers are reporting trouble with mice that follow mole holes to the base of the plants or even make tunnels of their own. Both moles and mice can be discouraged by any system of cultivation that will tear out the ridge in the rows between the plants. With black rasperries check cultivating will do this, but with trelised plants a grape hoe is best Mise can be poisoned easily by mixing 1 ounce strychnine (alkaloid) one eighth ounce saccharine and 12 quarts outmeal. Scatter it in holes or runways.-O. A. C. Experiment sta-
