ONLY ONE SIGNATURE.

The Attempt of the People's Party to Organize a Club at Needy.

NEEDY, April 18.—Pursuant to call the citizens of Needy precinct met at the usual place of voting last Saturday evening for the purpose of organizing a people's party club. The audience was about equally composed of democrats and republicans. Among those present were Albert Gribble, Wm. Gribble, Walter Noblitt, J. H. Wolfer, S. W. Harlesty, Geo. Kinzer, J. E. Mills, Mr. Ed. Rausdell and quite a number of others. The meeting was called to order by F. M. Mathews and organized by electing Samuel Wolfer chairman and Mr. J. D. Ritter secretary, both republicans. The following call was presented by Mr. Mathews and read by the secretary:

We the undersigned citizens of Needy precinct do hereby form ourselves into a people's party club for the advancement and education of the cause of the people's party.

The chair then announced that signatures to the call were in order and extended an invitation to all who felt inclined to do so to come forward and sign the paper. George Kinzer objected to signing until the chairman and secretary had first signed. Both the chairman and secretary did not see it in that light. J. H. Wolfer then arose to ask for information in regard to the platform, by-laws, initiation fees, etc., as he would like to know what he was signing. Mr. Mathews then said that the object of the meeting was to form a people's party club, and he stated among other things that the Australian ballot law deprived his party of the right of suffrage in this precinct, and that it required ten members to form a club here. The chair insisted that it was now in order to sign the paper, whereupon Mr. Mathews, being the only member of his party in this precinct, stepped forward and signed his name to the call. After considerable discussion by Messrs. Gribble, Thompson and others, a motion was adopted that the chair appoint a committee of three on resolutions and platform. The chair announced that the call still had but one name, but no one responding the chair proceeded to appoint the committee, naming Messrs. Thompson, Blair and Oglesby.

About this time there seemed to be considerable confusion and the chair demanded more signatures as the paper was now ready and waiting. Mr. Gribble seemed in doubt as to whether the motion for a committee had carried, and called for a division of the house. Here the chair again announced that the paper still had but one signature.

Mr. Mathews then took the floor and said that he wanted to organize a people's party and had no use for a committee. Whereupon the chair emphatically insisted that there must be more signatures to the call in order that Mr. Mathews could accomplish his object.

About this time Mr. Mathews seemed to realize that he had made a mistake and got into the wrong pew, and said that a motion to adjourn would be in order. Thereupon the chair informed him that there was still but one name signed to the call.

Albert Gribble moved to adjourn and the motion prevailed.

Great enthusiasm was manifested by the members of the two old parties present. The chair announced on adjourning the meeting that there was still only one signature to the paper.

HIGHLAND, April 16.—Grim death has again visited our neighborhood and claimed for its victim Mrs. Mary Jones, wife of Thomas B. Jones. Mrs. Jones was stricken with paralysis Tuesday, April 12, while sitting in her chair.
