ADJOURNED CIRCUIT COURT.

Several Important Cases Disposed of—Jury Discharged Saturday.

J. H. Lee & Co. vs Hamilton Bros.; Emmons & Emmons for plaintiffs, and C. H. Dye for defendants; ordered that plaintiff's recover the sum of \$754, with interest thereon and costs, and the property attached be sold to satisfy said judgment, but no execution to issue unless assignment of Hamilton Bros. is set aside.

Hattie A. Kellogg, of Barlow, was granted a divorce from William S. Kellogg. Her attorney was George C. Brownell, and in her complaint she alleges brutal treatment. The court granted Mrs. Kellogg the custody of five minor children, and decreed that she retain one-third interest in lot 5 in block 3, in the town of Barlow, and that she recover of defendant the sum of \$500 alimony and that his interest in said lot above described be sold as upon execution to satisfy said sum of \$500 alimony as aforesaid, and the costs thereof, and that plaintiff be permitted to become a purchaser of said property at said sale, and that the decree be a lien upon said interest of said defendant in said lot from the date of the entry thereof.

J. F. Anderson vs The Portland Flouring Mills Company. A motion was made by defendant's attorneys for nonsuit, but plaintiff's attorneys excepted to the ruling and were allowed 30 days to file bill of exceptions.

Chester Williams vs Hamilton Bros.; motion made by L. L. Porter, plaintiff's attorney, to retax costs, which was disallowed; C. H. Dye for defendants.

R. L. Sabin vs Hamilton Bros.; motion by plaintiff's attorney, L. L. Porter, to retax costs was disallowed; C. H. Dye for defendants.

Clarence Farr vs J. S. Williams; dismissed.

Alex Sweek vs Marion Johnson and Mary Johnson; A. F. Sears, Jr. for plaintiff, H. E. Cross and Caples & Allen for defendant; dismissed.

James Abraham vs Marion Johnson and Mary Johnson; on motion W. Cary Johnson, plaintiff's attorney, case was dismissed.

D. M. Osborne & Co. vs O. F. Hibbard; E. F. Driggs for plaintiff, and George C. Brownell for defendant; this case was hotly contested, and the jury brought in a verdict for the defendant.

James Humphrey versus A. M. Shibley, was a suit brought to collect notes aggregating \$2,390, alleged to have been given to Ezra Durand, the erstwhile Oregon dealer of Portland, who took notes for certificates of stock in a proposed organ factory, and was accused of forging others. Mr. Durand skipped the country to escape prosecution for forgery and obtaining money under false pretenses, and is now reported to be living as comfortably in South America as his conscience will allow him, if he has any. Mr. Shibley is a highly respected farmer of Springwater, and was one of Durand's numerous victims. These notes came into the hands of James Humphrey, but Mr. Shibley claimed he never executed them. The case came up for a hearing last Friday with J. V. Beach and A. F. Sears, Jr., for Humphrey and George C. Brownell and C. D. Latourrette for Shibley. Several witnesses were examined and after exhaustive argument by the counsel on both sides, the case was given to the jury, who returned after nine minutes with a verdict for the defendant. The Durand cases have had quite a court history in this county. James Humphrey's suit against Minerva Kandle was dismissed two years ago; one year ago Peter A. Weiss sued Mr. Shibley in a similar cause and the verdict was rendered for defendant. A non-suit was entered in the suit of Alex. Sweek, of Portland, against Marian Johnson for a Durand note at this term of court, and the suits of Sweek against Marian Phillips and James Abraham against Marian Johnson were dismissed. The only one of the Durand cases now pending in this county is that of M. K. Ferrin against Mr. Shibley.

Sidney Smyth chaperoned the General and his friend during their visit here and put them on to the best fishing holes. They go overland in a private S. P. car to San Francisco, and will stop off at good fishing places along the road.

E. B. May, a well known pioneer resident of Clackamas county, who came here in 1847, died at his home in Canemah last Monday afternoon of heart disease. He had been in poor health for some time, and was about six-five years of age. The funeral services were held in the Baptist church Tuesday afternoon, at two o'clock which was filled with a large number of friends, who had assembled to pay their last respects to one who in life was honored and respected. The services were conducted by Rev. M. L. Rugg at the church and the Old Fellows conducted the burial ceremonies at the cemetery. He leaves a widow, three sons and a daughter.

At the regular weekly meeting of McLaughlin Chautauqua circle held at the residence of Mrs. C. H. All three were taken in by Chief of Police Burns, and the two colored females were fined \$15 each by Recorder Fouts for assault.

Rinearson delivered an appropriate address, and A. F. Miller, lecturer of the state grange, made the after dinner speech. The Barlow orchestra furnished some excellent music, and a solo by Uncle Wm. S. McCord at the hands of B. C. Lewis, \$2.36 in full of his poll, county, school and territorial tax for the year 1857. A. Holcomb, Sheriff of Clackamas county."

COUNTY COURT PROCEEDINGS.

June Term 1895—G. E. Hayes Judge; R. Scott, F. Jaggur Commissioners.

The petition of R. J. Shockley, for a road of public easement was granted, and road ordered opened on payment of costs, \$6.85 and damages, \$15, total \$21.85, receipts of viewers being filed.

In the matter of the petition of Henry Wilbern, et al., for a change in the Foster and Milwaukee road, report filed and petition denied, as the reconstitutors exceeded the number of petitioners. Expense account of \$22 ordered paid.

The petition of J. G. Bleakney et al, for public aid for Ezra Rogers, was referred to Commissioner Scott, with power to act.

The petition of E. M. Atkinson et al, for a bridge across Newell creek on the Morton road was denied.

It was ordered that the allowance heretofore made for the support of Mrs. Nilsen, be discontinued from July 1st 1895.

In the matter of the care and keeping of Mrs. Martha Mail, it was ordered that she be allowed for said purpose, and that a warrant for \$6 be now drawn for immediate necessities.

It appearing from the statement of M. J. Snyder, who certified under oath that he was over fifty years of age, it was ordered that his road poll tax for \$2 be refunded.

The petition of the board of directors of school district No. 1, for delinquent taxes to be paid to school districts, was denied.

It was ordered that the allowance heretofore made for care and keeping of Joseph Rancy, be reduced to \$5 per month to date from June 1st.

In the matter of the petition of C. N. Greenman et al, for the county to grant relief to Ellen and Gowan Bridges, it was ordered that \$8 per month be allowed for said purposes to be issued in favor of Ellen Bridges; a warrant for \$8 to be issued now for immediate use.

In the matter of the road supervisors for May, 1895, it was ordered that said reports be approved and expense of each district for road work for said month be paid as follows:
